Pursuant to sections 327, 330 and 331 of title 11 of the United States Code (as amended, the “Bankruptcy Code”), Rule 2016 of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”), and Rule 2016-1 of the Local Bankruptcy Rules of the United States Bankruptcy Court for the Southern District of New York (the “Local Rules”), the *Order Authorizing the Retention and Employment of Katten Muchin Rosenman LLP as Conflicts Counsel to the Debtors Effective Nunc Pro Tunc to the Petition Date* [Docket No. 369], and the *Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses for Retained Professionals*, entered on April 22, 2019 [Docket No. 374] (the “Interim Compensation Order”), the law firm of Katten Muchin Rosenman LLP (“Katten”), conflicts counsel to the above-captioned debtors and debtors in possession (the “Debtors”) hereby submits this *Monthly Statement of Services Rendered and Expenses Incurred for the Period From April 1, 2019 Through April 30, 2019* (this “Fee Statement”).³ Specifically, Katten seeks (i) interim allowance of \$931,076.50 for the reasonable compensation for actual, necessary legal services that Katten rendered to the Debtors during the Fee Period; (ii) compensation in the amount of \$744,861.20, which is equal to 80% of the total amount of reasonable compensation for actual, necessary legal services that Katten rendered during the Fee Period (i.e.

\$931,076.50); (iii) allowance and payment of \$24,179.17 for the actual, necessary expenses that Katten incurred in connection with such services during the fee Period.

Itemization of Services Rendered and Disbursements Incurred

1. Attached hereto as **Exhibit A** is a schedule of the number of hours expended and fees incurred (on an aggregate basis) by Katten partners, associates, and paraprofessionals during the Fee Period with respect to each of the project categories Katten established in accordance with its internal billing procedures. As reflected in **Exhibit A**, Katten incurred \$931,076.50 in fees during the Fee Period. Pursuant to this Fee Statement, Katten seeks payment of 80% of such fees (\$744,861.20 in the aggregate).

2. Attached hereto as **Exhibit B** is a schedule of Katten professionals and paraprofessionals, including the standard hourly rate for each attorney and paraprofessional who rendered services to the Debtors in connection with these Chapter 11 cases during the Fee Period and the title, hourly rate, aggregate hours worked and the amount of fees earned by each professional. The blended hourly billing rate of attorneys for all services provided during the Fee Period is \$787.⁴ The blended hourly billing rate of all paraprofessionals is \$214.⁵

3. Attached hereto as **Exhibit C** is a schedule for the Fee Period setting forth the total amount of payment sought with respect to each category of expenses for which Katten is seeking payment in this Monthly Fee Statement. All of these disbursements comprise the requested sum for Katten's out-of-pocket expenses, which total \$24,179.17.

4. Attached hereto as **Exhibit D** are the time records of Katten, which provide a daily summary of the time spent by each Katten professional and paraprofessional during the Fee Period as well as an itemization of expenses by project category.

5. Although every effort has been made to include all fees and expenses incurred in the Fee Period, some fees and expenses might not be included in this Fee Statement due to delays caused by accounting and processing during the Fee Period. Katten reserves the right to make further application to the United States Bankruptcy Court for the Southern District of New York for allowance of such fees and expenses not included herein. Subsequent Fee Statements will be filed in accordance with the Bankruptcy Code, the Bankruptcy Rules, Local Rules, and the Interim Compensation Order.

Notice

6. The Debtors will provide notice of this Fee Statement in accordance with the Interim Compensation Order. The Debtors submit that no other or further notice be given.
