ORDER AUTHORIZING AND APPROVING THE REJECTION OF CERTAIN EXECUTORY CONTRACTS

Upon the notice, dated May 15, 2019 (the "Rejection Notice")² of the above-captioned debtors and debtors in possession (collectively, the "Debtors") for entry of an order (this "Order"), providing notice that certain Contracts set forth on the schedule attached to the Rejection Notice are to be rejected under 11 U.S.C. § 365, all as more fully set forth in the Rejection Notice; and this Court having jurisdiction over this matter pursuant to 28 U.S.C. §§ 157(a)-(b) and 1334(b) and the Amended Standing Order of Reference from the United States District Court for the Southern District of New York, dated January 31, 2012, as a core proceeding under 28 U.S.C. § 157(b) that this Court may decide by a final order consistent with Article III of the United States Constitution; and this Court having found that venue of the Rejection Notice in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and this Court having found that the Debtors' notice of the Rejection Notice and the opportunity for a hearing thereon was due and sufficient under the circumstances and consistent with the Court's prior order establishing rejection

procedures and that no other notice need be provided; and counsel for the Debtors having represented that there was no objection to the relief granted hereby; and after due deliberation this Court having determined that the legal and factual bases set forth in the Rejection Notice establish sufficient cause for the relief granted herein and that the rejection of the following Contracts is a proper exercise of business judgment and in the best interests of the Debtors and their estate; now, therefore, it is HEREBY ORDERED THAT:

- 1. The Contracts listed on the schedule attached hereto as **Exhibit A** and subject to the Rejection Notice dated May 15, 2019 are rejected under 11 U.S.C. § 365 as of the Rejection Date set forth in the Rejection Notice and such schedule.
- 2. Proofs of Claim arising out of such rejection shall be filed by **4:00 p.m. Eastern**Time on August 15, 2019. FAILURE TO TIMELY SUBMIT A PROOF OF CLAIM IN THE APPROPRIATE FORM ON OR BEFORE THE DEADLINE SET FORTH HEREIN, YOU WILL BE FOREVER BARRED, ESTOPPED, AND ENJOINED FROM (A) ASSERTING SUCH CLAIM AGAINST ANY OF THE DEBTORS AND THEIR CHAPTER 11 ESTATES, (B) VOTING ON ANY CHAPTER 11 PLAN OF REORGANIZATION FILED IN THESE CASES ON ACCOUNT OF SUCH CLAIM, AND (C) PARTICIPATING IN ANY DISTRIBUTION IN THE DEBTORS' CHAPTER 11 CASES ON ACCOUNT OF SUCH CLAIM.
- 3. The Debtors and their notice and claims agent are authorized to take all actions necessary to effectuate the relief granted pursuant to this Order and in accordance with the Rejection Notice.
- 4. Notice of the Rejection Notice, as provided therein, shall be deemed good and sufficient notice of such Rejection Notice and the requirements of Bankruptcy Rule 6004(a) and the Local Bankruptcy Rules are satisfied by such notice.
