FIRST SUPPLEMENTAL DECLARATION OF STEVEN J. REISMAN IN SUPPORT OF THE DEBTORS' APPLICATION FOR ENTRY OF AN ORDER AUTHORIZING THE RETENTION AND EMPLOYMENT OF KATTEN MUCHIN ROSENMAN LLP AS CONFLICTS COUNSEL FOR THE DEBTORS AND DEBTORS IN POSSESSION EFFECTIVE NUNC PRO TUNC TO THE PETITION DATE

I, STEVEN J. REISMAN, being duly sworn, state the following under penalty of perjury:

- 1. I am a partner of the law firm of Katten Muchin Rosenman LLP, located at 575 Madison Avenue, New York, NY 10022, ("Katten").² I am one of the lead attorneys from Katten working on the above-captioned Chapter 11 cases. I am a member in good standing of the Bar of the State of New York, and I have been admitted to practice in the Southern District of New York. There are no disciplinary proceedings pending against me.
- 2. On February 25, 2019 (the "<u>Petition Date</u>"), the above-captioned debtors and debtors in possession (collectively, the "<u>Debtors</u>") filed petitions with this Court under Chapter 11 of title 11 of the United States Code (the "<u>Bankruptcy Code</u>"). On March 26, 2019, the Debtors filed an application to employ and retain Katten as conflicts counsel for the Debtors [Docket No.

194] (the "<u>Application</u>") pursuant to sections 327(a) and 330 of the Bankruptcy Code, rules 2014(a) and 2016 of the Federal Rules of Bankruptcy Procedure (the "<u>Bankruptcy Rules</u>"), and rules 2014-1 and 2016-1 of the United States Bankruptcy Court for the Southern District of New York.

- 3. My declaration in support of the Application (the "Original Declaration") was attached to the Application as **Exhibit B**. On April 22, 2019, the Court entered the *Order Authorizing the Retention and Employment of Katten Muchin Rosenman LLP as Conflicts Counsel for the Debtors and Debtors in Possession Effective Nunc Pro Tunc to the Petition Date* [Docket No. 369] (the "Retention Order").
- 4. I submit this declaration (the "<u>First Supplemental Declaration</u>") to provide additional disclosures in accordance with rules 2014(a) and 2016(b) under the Bankruptcy Rules and as required pursuant to the Retention Order. Except as otherwise noted, I have personal knowledge of the matters set forth herein.

Katten's Disinterestedness

- 5. The Application stated that Katten would review its files periodically during these Chapter 11 cases and use reasonable efforts to ensure that no conflicts or other disqualifying circumstances exist or arise. Katten has reviewed its files for connections to any additional parties in interest in these Chapter 11 cases not already searched in connection with the Original Declaration and any new connections to potential parties in interest previously searched in connection with such declaration.
- 6. Katten has searched its electronic database for connections related to the entities listed on <u>Schedule 1</u> attached hereto (the "<u>Parties</u>"). The information listed on <u>Schedule 2</u> might have changed without our knowledge and might change during these Chapter 11 cases.

Accordingly, Katten will continue to update the First Supplemental Declaration and Original Declaration as necessary and when Katten becomes aware of additional material information.

7. The following categories of Parties have been searched:³

- 8. For the avoidance of doubt, Katten will not commence a cause of action in these Chapter 11 cases against the entities lists on <u>Schedule 2</u>⁴ (including entities listed below under the "Specific Disclosures" section of this Declaration) that are current clients of Katten unless Katten has an applicable waiver on file or first receives a waiver from such entity allowing Katten to commence such an action.
- 9. Katten's conflicts search of the entities listed on Schedules 1(a)–1(g) (that Katten was able to locate using its reasonable efforts) reveals, to the best of Katten's knowledge, that those Katten attorneys and paraprofessionals who previously worked at other law firms that represented such entities in these Chapter 11 cases have not worked on matters relating to the Debtors' restructuring efforts while at Katten.

As referenced in Schedule 2, the term "former client" means an entity listed as a client in Katten's conflicts search system to which time was posted between 12 and 36 months preceding the Petition Date. As referenced in Schedule 2, the term "closed client" means an entity listed as a client in Katten's conflicts search system to which time was posted in the 36 months preceding the Petition Date but for which the client representation has been closed. Whether an actual client relationship exists can only be determined by reference to the documents governing Katten's representation rather than its potential listing in Katten's conflicts search system. The list generated from Katten's conflicts search system is over-inclusive. As a general matter, Katten's discloses connections with "former clients" or "closed clients" for whom time was posted in the last 36 months but does not disclose connections if time was billed more than 36 months before the Petition Date.

- 10. Generally, it is Katten's policy to disclose entities in the capacity that they first appear in a conflicts search. For example, if an entity has already been disclosed in the Original Declaration or this First Supplemental Declaration in one capacity (*e.g.*, a customer), and the entity appears in a conflicts search in a different capacity (*e.g.*, a vendor), Katten does not disclose the same entity again in supplemental declarations, unless the circumstances are such in the latter capacity that additional disclosure is required.
- Original Declaration, to the best of my knowledge, neither I, Katten, nor any partner or associate thereof, insofar as I have been able to ascertain, have any connection with the Debtors, their creditors, or any other parties in interest, their respective attorneys and accountants, the Office of the United States Trustee for the Southern District of New York (the "U.S. Trustee"), any person employed by the U.S. Trustee, or any Bankruptcy Judge currently serving on the United States Bankruptcy Court for the Southern District of New York, except as disclosed or otherwise described herein and in the Original Declaration.

Specific Disclosures

12. As specifically set forth below, in the attached exhibits, and in the Original Declaration, Katten represents certain of the Debtors' creditors, equity security holders, or other entities that may be parties in interest in ongoing matters unrelated to the Debtors and these Chapter 11 cases. None of the representations described herein are materially adverse to the interests of the Debtors' estates. Moreover, pursuant to section 327(c) of the Bankruptcy Code, Katten is not disqualified from acting as the Debtors' counsel merely because it represents certain of the Debtors' creditors, equity security holders, or other entities that may be parties in interest in matters unrelated to these Chapter 11 cases.

Connections to Holders of Claims Against the Debtors

13. As disclosed in the Original Declaration and on Schedule 2, Katten currently represents, formerly represented, and in the future may represent UMB Financial Corporation ("UMB"). UMB is a creditor of the Debtors and a member of the Official Committee of Unsecured Creditors (the "UCC"). The Original Declaration disclosed that, "from March 2018 through June 2018, and prior to being retained by the prepetition Debtors, Katten represented UMB in certain matters related to the prepetition Debtors." Original Declaration ¶ 32. However, since filing the Original Declaration, it has come to my attention that Katten's representation of UMB in matters related to the prepetition Debtors ended in February 2019, prior to Katten's retention by the Debtors. As disclosed in the Original Declaration, Katten has erected appropriate ethical walls to ensure that any attorneys or paraprofessionals involved in the representation of UMB are screened from Katten's representation of the Debtors. Such screened attorneys will not perform work in connection with Katten's representation of the Debtors and will not have access to any information related to the representation.

Affirmative Statement of Disinterestedness

14. Based on the conflicts search conducted to date and described herein and in the Original Declaration, to the best of my knowledge and insofar as I have been able to ascertain, (a) Katten is a "disinterested person" within the meaning of section 101(14) of the Bankruptcy Code, as required by section 327(a) of the Bankruptcy Code, and does not hold or represent an interest adverse to the Debtors' estates and (b) Katten has no connection to the Debtors, their creditors, or other parties in interest, except as may be disclosed herein and in the Original Declaration.
