respectfully state as follows in support of this motion:

Relief Requested

1. The Debtors seek entry of an order, substantially in the form attached hereto as

Exhibit A (the "Order") authorizing the Debtors to assume the unexpired leases of non-residential

real property, including any amendments, modifications, or subleases thereto, each of which is set forth on <u>Schedule 1</u> to <u>Exhibit A</u>, and pay applicable cure costs, if any.

2. The Debtors submit the declaration of Nicholas Grossi (the "<u>Grossi Declaration</u>"), attached hereto as **Exhibit B**, in support of the relief requested herein.

Jurisdiction and Venue

3. The United States Bankruptcy Court for the Southern District of New York (the "<u>Court</u>") has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334 and the *Amended Standing Order of Reference from the United States District Court for the Southern District of New York*, dated February 1, 2012. The Debtors confirm their consent, pursuant to rule 7008 of the Federal Rules of Bankruptcy Procedure (the "<u>Bankruptcy Rules</u>"), to the entry of a final order by the Court in connection with this motion to the extent that it is later determined that the Court, absent consent of the parties, cannot enter final orders or judgments in connection herewith consistent with Article III of the United States Constitution.

4. Venue is proper pursuant to 28 U.S.C. §§ 1408 and 1409.

5. The bases for the relief requested herein are sections 363 and 365 of title 11 of the United States Code, 11 U.S.C. §§ 101–1532 (the "<u>Bankruptcy Code</u>"), Bankruptcy Rules 6004, 6006, and 6007, and rules 6006-1 and 6007-1 of the Local Bankruptcy Rules for the Southern District of New York (the "<u>Local Rules</u>").

Background

6. The Debtors are a leading provider of advanced network communications and technology solutions for businesses across the United States. The Debtors also offer broadband, entertainment and security solutions to consumers and small businesses primarily in rural areas in 18 states. Additionally, the Debtors supply core transport solutions on a local and long-haul fiber network spanning approximately 150,000 miles and have over 11,000 employees.

7. On February 25, 2019 (the "<u>Petition Date</u>"), each of the Debtors filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code. A detailed description of certain facts and circumstances surrounding these chapter 11 cases is set forth in the *Declaration of Tony Thomas, Chief Executive Officer and President of Windstream Holdings, Inc., (I) in Support of Debtors' Chapter 11 Petitions and First Day Motions and (II) Pursuant to Local Bankruptcy Rule 1007-2* [Docket No. 27] (the "<u>First Day Declaration</u>"), filed on the Petition Date.

8. The Debtors' chapter 11 cases have been consolidated for procedural purposes only and are being jointly administered pursuant to Bankruptcy Rule 1015(b) [Docket No. 56]. The Debtors continue to operate their business and manage their property as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. On March 12, 2019, the United States Trustee for the Southern District of New York appointed the creditors' committee pursuant to section 1102 of the Bankruptcy Code [Docket No. 136].

The Assumed Leases

9. As part of their ongoing restructuring efforts, the Debtors seek to assume approximately 585 non-residential real property leases (collectively, the "Leases") pursuant to this motion. The decision to assume the Leases results from a detailed and thorough analysis of the Debtors' contract portfolio and after a negotiation process with various contract counterparties that have taken place over many months since the Petition Date. The Debtors, in an exercise of their business judgment, have determined that the Leases are critical to their operations, as such agreements allow Debtors to use office spaces, warehouses, and other premises for their necessary to operate their telecommunication business. Therefore, it is in the best interests of the Debtors

and their estates to assume the Leases set forth on <u>Schedule 1</u> attached to the Order (as may be modified, supplemented, or otherwise amended from time to time, the "<u>Assumption List</u>").²

10. On June 20, 2019, the Court granted additional time to assume non-residential real property leases pursuant to the order extending the deadline under section 365(d)(4) of the Bankruptcy Code (the "Lease Extension Order") [Docket No. 700].³ Pursuant to the Lease Extension Order, the Debtors have until September 23, 2019, (the "<u>Assumption Deadline</u>") to determine whether to assume the real property leases in their contract portfolio, which consists of thousands of agreements.

11. Due to the impracticality of securing individual extensions of the Assumption Deadline from hundreds of landlords, the Debtors have determined to assume all unexpired leases of non-residential real property, except for limited circumstances where the Debtors have agreed to an extension of the Assumption Deadline with landlords or purported landlords or with counterparties that are still conducting diligence (or where the Debtors have already determined to reject). The Debtors conducted an extensive and in-depth review of their contract portfolio to determine which agreements constitute unexpired leases of non-residential real property subject to the Assumption Deadline. After this review, the Debtors identified those leases set forth on the Assumption list, which does not include certain agreements, such as colocation agreements, network, fiber, and equipment agreements, easement and rights-of-way agreements, and certain other similar agreements that, in the Debtors' view, do not constitute unexpired leases of non-

² The Debtors' review of their contract portfolio remains ongoing and may result in additional contracts being added to or removed from the Assumption List prior to the Assumption Deadline (defined below).

³ Pursuant to Local Rule 6006-1(c), filing a motion to assume an unexpired lease of real property prior to September 23, 2019, automatically extends the deadline for the automatic rejection of non-residential leases of real property pending the Court's resolution of the relief requested by this motion.

residential real property. Those agreements not listed on the Assumption List will remain the subject of ongoing analysis (and assumption or rejection) pending confirmation of a chapter 11 plan and emergence from these chapter 11 cases.

12. The Debtors have evaluated the terms, operational considerations, and expected cure costs (collectively, the "<u>Cure Costs</u>"), among other things, of the non-residential real property leases set forth on the Assumption List and concluded that assumption is in the best interest of their estates. If the Leases are not assumed, the Debtors would risk disruptions to their telecommunications and network operations, as finding replacement agreements would be challenging and impracticable in many instances. Further, the Debtors do not believe that there would be significant cost savings in entering into new contracts because the Leases are consistent with or below market rates. The Debtors estimate the Cure Costs to be approximately \$1.7 million in the aggregate as of the date hereof, an amount the Debtors deem reasonable in light of the potential burdens related to rejection. For these reasons, the Debtors seek to assume the Leases pursuant to the motion.

Basis for Relief

I. It is an Exercise of the Debtors' Sound Business Judgment to Assume the Leases that are in the Best Interests of the Estates.

13. Section 365(a) of the Bankruptcy Code provides that a debtor in possession, "subject to the court's approval, may assume . . . unexpired lease of the debtor." 11 U.S.C. § 365(a); *see also NLRB v. Bildisco & Bildisco*, 465 U.S. 513, 521 (1984) ("This language by its terms includes all executory contracts except those expressly exempted."). It is well-established that a debtor's decision to assume an unexpired lease of real property under section 365(a) of the Bankruptcy Code is a matter within the "business judgment" of the debtor. *See In re Orion Pictures Corp.*, 4 F.3d 1095, 1099 (2d Cir. 1993); *In re Minges*, 602 F.2d 38, 43 (2d Cir. 1979);

In re Sabine Oil & Gas Corp., 547 B.R. 66 (Bankr. S.D.N.Y. 2016), aff'd 567 B.R. 869 (S.D.N.Y. 2017). This standard requires a court to approve a debtor's business decision unless that decision "derives from bad faith, whim, or caprice." In re Helm, 335 B.R. 528, 538 (Bankr. S.D.N.Y. 2006) (quoting In re Cent. Jersey Airport Servs., LLC, 282 B.R. 176, 183 (Bankr. D.N.J. 2002) (internal guotations omitted)); see also In re Riodizio, Inc., 204 B.R. 417, 424 (Bankr. S.D.N.Y. 1997) ("[A] court will ordinarily defer to the business judgment of the debtor's management"). Courts have considered it to be a sound exercise of business judgment to assume an unexpired lease under section 365(a) when it would benefit the estate. See In re Orion Pictures Corp., 4 F.3d at 1098-9; In re Stable Mews Assocs., Inc., 41 B.R. 594, 596 (Bankr. S.D.N.Y. 1984); In re Summit Land Co., 13 B.R. 310, 315 (Bankr. D. Utah 1981) (holding that absent extraordinary circumstances, court approval of a debtors' decision to assume or reject an executory contract "should be granted as a matter of course."). While not defined in the Bankruptcy Code, legislative history indicates that non-residential real property leases are intended to cover only "true" or "bona fide" leases. See Liona Corp., N.V. v. PCH Assocs. (In re PCH Assocs.), 804 F.2d 193, 201 (2d Cir. 1986) (addressing the phrase as used in section 502(b)(6), "[t]he Senate Report notes that the phrase 'lease of real property' . . . applies only to a 'true' or 'bona fide' lease." (citing S. Rep. No. 989, 95th Cong., 2d Sess. 64, reprinted in 1978 U.S. Code Cong. & Ad. News 5787, 5850)).

14. The Debtors exercised sound business judgment in deciding to assume the Leases, as assumption is in the best interests of their estates. The Leases are important to continuing their operations in the ordinary course while in these chapter 11 cases and post-emergence. Specifically, the premises tied to the Leases serve either administrative or operational functions that are related to their telecommunications, network, or business support services. The Debtors analyzed the Leases in detail and concluded that they are consistent with or under market value, would be

challenging or impracticable to replace, and could cause substantial disruptions to their operations if they were rejected. Accordingly, the Debtors submit that their decision to assume the Leases satisfies the business judgment standard, and this Court should authorize the Debtors to assume such Leases.

II. The Debtors Will Cure All Defaults and Have Provided Adequate Assurance of Future Performance.

15. Section 365(b) of the Bankruptcy Code provides that a debtor may assume an unexpired lease of real property if the debtor "cures" the default and provides "adequate assurance of future performance" under the lease. *See* 11 U.S.C. § 365(b)(1). Here, the Debtors believe that they have appropriately estimated the Cure Costs, which are set forth on the Assumption List. The Cure Costs were calculated based on the Debtors' books and records and in accordance with the terms of the Leases. If any counterparty to the Leases disputes the amount of the Cure Costs, the Debtors will work to resolve such disagreement promptly and consensually. In accordance with the Order, the Debtors will pay the appropriate Cure Costs either (a) within thirty days after the Order has been entered and for which there is no dispute as to the appropriate amount or (b) on the date set forth in the Court order resolving a dispute regarding the Cure Cost associated with a particular Lease; *provided* that the Debtors and the contract counterparty may modify the date on which the Cure Cost must be paid upon mutual agreement and without further notice or the Court's approval.⁴ Accordingly, the Debtors submit that they have complied with section 365(b)(1)(A) of the Bankruptcy Code.

⁴ Nothing in the Bankruptcy Code requires disputes over the amount of cure payments be resolved prior to or contemporaneously with a court authorizing a debtor to assume unexpired leases. The Bankruptcy Code merely requires that a debtor "provide[] adequate assurance that [it] will promptly cure" the actual amount of a default under the applicable executory contract or unexpired lease. 11 U.S.C. § 365(b)(1)(A).

16. Further, the present facts and circumstances also demonstrate that the Debtors' counterparties have been or will be provided with adequate assurance of future performance. "A debtor need not provide an absolute guarantee of performance; rather, it must simply appear that the rent will be paid and other lease obligations met." *In re Great Atl. & Pac. Tea Co., Inc.*, 472 B.R. 666, 674–75 (S.D.N.Y. 2012) (omitting citations and internal quotations). Courts evaluate "a non-exclusive list of factors, including the debtor's payment history, the extent and history of defaults, presence of a guarantee and/or a security deposit, evidence of profitability, a plan with earmarked funds exclusively for the landlord, the general outlook in the debtor's industry, and whether the lease is at or below the prevailing market rate" to determine whether a landlord is adequately assured. *Id.* at 675. The Debtors submit that their prior performance under the Leases, diligence in remaining current on certain postpetition obligations, and their ability to continue operating in the ordinary course constitute adequate assurance of future performance. The Debtors have sufficient liquidity and access to financing to continue to meet their obligations under the Leases.

Motion Practice

17. This motion includes citations to the applicable rules and statutory authorities upon which the relief requested herein is predicated and a discussion of their application to this motion. Accordingly, the Debtors submit that this motion satisfies Local Rule 9013-1(a).

18. the Motion were appropriate under the circumstances and no other notice need be provided; and this Court having reviewed the Motion and having heard the statements in support of the relief requested therein at a hearing before this Court (the "<u>Hearing</u>"); and this Court having determined that the legal and factual bases set forth in the Motion and at the Hearing establish just cause for the relief granted herein; and upon all of the proceedings had before this Court; and after due deliberation and sufficient cause appearing therefor, it is HEREBY ORDERED THAT:

1. The Motion is granted to the extent set forth herein.

2. The Debtors are authorized to assume the Leases pursuant to section 365 of the Bankruptcy Code.

3. The Debtors are authorized to pay in full any Cure Costs.

4. The Leases shall be assumed as of the applicable assumption effective date that is set forth on <u>Schedule 1</u> attached hereto, notwithstanding any pending objection regarding the proposed Cure Costs, and all rights with respect to any pending objection are reserved. The Debtors shall pay the proposed Cure Costs either (a) within thirty days after the Order has been entered and for which there is no dispute as to the appropriate amount or (b) on the date set forth in the Court's order resolving a dispute regarding the Cure Cost associated with a particular Lease; *provided* that the Debtors and the contract counterparty may modify the date that the Cure Cost must be paid upon mutual agreement and without further notice or the Court's approval. To the extent the Debtors and applicable Lease counterparty are not able to agree to the amount of any disputed Cure Costs for which an objection was timely filed, the parties may seek a ruling of this Court by timely noticing such objection for hearing for the next scheduled omnibus hearing date. No dispute as to the Cure Cost under a Lease shall affect the effective date of such Lease assumption in accordance with this Order.

5. If the parties are unable to agree on and disputed Cure Costs for which an objection was timely filed or an order of the Court determines a Cure Cost under a Lease to be greater than the amount listed in the <u>Schedule 1</u> attached hereto, the Debtors are authorized to amend the Assumption List to remove the such Lease; *provided* that the rejection date for such Lease shall be the same as the date of this Order unless the Debtors and the applicable contract counterparty agree otherwise.

6. Upon the entry of this Order and payment of any Cure Costs in accordance with the preceding paragraphs 4 and 5 of this Order, the counterparties of the Leases shall be forever barred and enjoined from asserting against the Debtors any defaults, claims, interest, or other default penalties under the Leases arising before the date of this Order.

7. To the extent any executory contract or unexpired lease to which the Debtors are party is not listed on <u>Schedule 1</u> attached to this Order and is later determined by the Court to constitute a lease of non-residential real property subject to the time period set forth in section 365(d)(4) of the Bankruptcy Code, such lease of non-residential real property shall be deemed assumed effective as of September 23, 2019, subject to the payment of any undisputed Cure Costs in accordance with paragraphs 4 and 5 of this Order. To the extent the Debtors and the applicable counterparty to such lease of non-residential real property are unable to agree to the amount of any Cure Costs, (a) the parties may seek a ruling of this Court by timely noticing such dispute for hearing for the next scheduled omnibus hearing date or (b) the Debtors are authorized to treat such lease of non-residential real property as rejected effective as of September 23, 2019 in accordance with section 365(d)(4) of the Bankruptcy Code.

8. With the consent of Georgia Power Company ("<u>GPC</u>"), Southern Telecom, Inc. ("<u>STI</u>"), and Southern Company Services, Inc. ("<u>SCS</u>"), the Debtors' deadline to assume or reject

any non-residential real property lease under section 365(d)(4) of the Bankruptcy Code, to the extent applicable, to which any of GPC, STI or SCS is party, is extended to December 15, 2019.

Anything in the Motion or this Order to the contrary notwithstanding, including but not limited to, paragraph 7 of this Order (which provisions shall not apply to GPC, STI or SCS) each of GPC, STI, SCS, and the Debtors reserves all of its rights, claims and defenses with respect to any executory contract or unexpired lease to which any of GPC, STI or SCS and any of the Debtors are parties. In the case of GPC, STI and SCS, such reservation of rights, claims and defenses shall include, but not be limited to, the right to argue that such executory contract or unexpired lease is not a non-residential real property lease; to challenge any "Cure" amount proposed by the Debtors in connection with assumption of the executory contract or unexpired lease now existing or hereafter arising; and to file a motion requesting that this Court approve an order requiring the applicable Debtor to assume or reject any executory contract or unexpired lease within a specified period of time. In the case of the Debtors, such reservation of rights, claims and defenses shall include, but not be limited to, the right to object to the foregoing.

10. Assumption of the Leases or payment of an associated Cure Cost does not represent a waiver by the Debtors of any rights, claims, or defenses in connection with or arising under any Lease.

11. Nothing relating to the Motion or Order or any payment made pursuant to this Order will impair, prejudice, waive, or otherwise affect the rights of the Debtors and their estates to assign the Leases pursuant to and in accordance with the requirements of section 365 of the Bankruptcy Code, subject to appropriate notice and a hearing and this Court's approval unless the

applicable parties and the Debtors agree otherwise. Such assignment may be effectuated through a chapter 11 plan and confirmation order or separate motion.

13. The Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation of this Order.

2. I am generally familiar with the Debtors' day-to-day operations, business and financial affairs, and books and records. Except as otherwise indicated, all facts in this declaration are based upon my personal knowledge, my discussions with the Debtors' management team and advisors (including the A&M team working under my supervision), my review of relevant documents and information concerning the Debtors' operations, financial affairs, and restructuring initiatives, or my opinions based upon my experience and knowledge. I am over the age of eighteen and authorized to submit this declaration on behalf of the Debtors. If called upon to testify, I could and would testify competently to the facts set forth in this declaration.

The Assumed Leases

3. The Debtors are seeking to assume the Leases for properties where the Debtors intend to continue operations post-emergence. Over the last several months, the Debtors have conducted a detailed and thorough analysis of the Debtors' contract portfolio and negotiated with various contract counterparties in anticipation of the Assumption Deadline. The Debtors and their advisors' analysis of the contract portfolio required an in-depth review of the agreement's terms, an assessment of the effect that the agreement has on the business, and a calculation of the expected Cure Costs, among other things. Based on my knowledge of this process and the information provided to me, it is my opinion that assuming the Leases are in the best interest of the Debtors' estates and ongoing operations.

4. The Leases are related to office spaces, warehouses, and other premises that the Debtors use to operate their telecommunication and network business. Some of these locations are where the Debtors exercise their exclusive right to use the premises to install, maintain, and

store their communication equipment and lines for the benefit of their customers and other thirdparty operators. The Leases are necessary for the Debtors' business, such that rejecting them would disrupt severely their telecommunications and network operations. Moreover, the Debtors' operations would be further adversely affected if they are unable to enter into alternative agreements similar to the Leases. In many cases, it would be challenging or impracticable for the Debtors to find an alternative agreement on the same terms and conditions as set forth in the Leases. Therefore, it is my opinion that such Leases should be assumed.

5. Further, it is my belief that the Cure Costs necessary to cure any existing defaults under the Leases are reasonable under the circumstances. The Cure Costs are estimated to be approximately \$1.7 million in the aggregate as of the date hereof, which, in addition to other considerations, have led me and the Debtors to believe that the rates under the Leases are consistent with the market. Some of the Leases have more favorable rates when compared to similar spaces in their respective local markets. Therefore, the long-term strategic value in assuming the Leases outweigh the Cure Costs associated therewith.

6. Moreover, the Debtors' request to assume the Leases are part of their larger restructuring efforts and intent to emerge from these chapter 11 cases as a viable business. It is my belief that the Debtors' intent to operate on a go-forward basis and ability to pay Cure Costs amount to adequate assurance that they will continue to perform obligations under the Leases.

7. I understand that the Leases are essential to the Debtors' go-forward business plan and losing these Leases would impose significant burdens on their operations. Accordingly, the Debtors' decision to assume the Leases is in the best interests of the Debtors and their estates.
