GROUNDS FOR RELIEF

The portions of Defendants' Response in Opposition to Plaintiffs' Motion to Exclude Testimony of Matthew Kardos that are proposed to be redacted were previously filed under seal by Charter.
- 5. The documents and information sought to be filed under seal have been designated as either CONFIDENTIAL or CONFIDENTIAL ATTORNEYS' EYES ONLY pursuant to the parties' Confidentiality Agreement and Stipulated Protective Order (ECF 74) or involve confidential subject matter derived from such documents.

11 U.S.C. § 107(b)(1).

7. Bankruptcy Rule 9018 further provides, in part:

On motion or on its own initiative, with or without notice, the court may make any order which justice requires (1) to protect the estate or any entity in respect of a trade secret or other confidential research, development, or commercial information

Fed. R. Bankr. P. 9018.

Upon the [unopposed] motion (the "Motion") of Defendants Charter Communications, Inc. and Charter Communications Operating, LLC (collectively "Charter") for entry of an order (this "Order") under 11 U.S.C. § 107 authorizing Charter to file under seal certain portions of Defendants' Response in Opposition to Plaintiffs' Motion to Exclude Testimony of Matthew Kardos ("Sealed Documents"); and the Court having found that Charter provided due and sufficient notice of the Motion and that no other notice or hearing is required; and, after due deliberation, this Court having determined that the legal and factual bases set forth in the Motion establishes sufficient cause for the relief granted herein, in that the proposed information that the

- 1. The Motion is granted as set forth herein.
- 2. Charter is authorized to filed under seal portions of Defendants' Response in Opposition to Plaintiffs' Motion to Exclude Testimony of Matthew Kardos by providing them to the Clerk's Office at 300 Quarropas Street, White Plains, New York along with a copy of this Order, and (b) to file a redacted version thereof on the public docket of this case; provided, that Charter redacts only that information that is considered confidential and commercially sensitive pursuant to Sections 105(a) and 107(b)(1) of the Bankruptcy Code, Bankruptcy Rule 9018, and Local Bankruptcy Rule 9018-1.
- 3. Except upon further order of the Court after notice to the Charter, the Sealed Documents shall remain under seal, and shall not be made available to anyone without the consent of Charter, with the exception that unredacted copies of the Sealed Documents shall be provided to (a) the Court, (b) the United States Trustee, (c) counsel to Plaintiffs, (d) counsel to the Official Committee of Unsecured Creditors appointed in these Chapter 11 cases, and (e) any other party as may be ordered by the Court or agreed to by Charter and a counterparty to any such Sealed Document, in each case, under appropriate confidentiality agreements satisfactory to Charter.
