**NOTICE OF (A) THE DEBTORS' ASSUMPTION
AND ASSIGNMENT OF CERTAIN EXECUTORY
CONTRACTS TO UNITI, (B) CURE AMOUNTS, IF ANY, AND
(C) RELATED PROCEDURES IN CONNECTION THEREWITH**

PLEASE TAKE NOTICE THAT on March 6, 2020, the above-captioned debtors and debtors in possession (collectively, the "Debtors") filed *Debtors' Motion for Entry of an Order Approving the Settlement Between the Debtors and Uniti Group Inc., Including (I) the Sale of Certain of the Debtors' Assets Pursuant to Section 363(B) and (II) the Assumption of the Leases Pursuant to Section 365(A)* [Docket No. 1558] (the "Motion"),² seeking approval of a settlement, as set forth in the Uniti Term Sheet, of the Debtors' claims and causes of action asserted in the Uniti Adversary Proceeding [Adv. Proc. Docket No. 1] originally scheduled to be heard on April 3, 2020.

PLEASE TAKE NOTICE THAT on May 12, 2020, United States Bankruptcy Court for the Southern District of New York (the "Court") entered an order [Docket No. 1807] (the "Order") approving the assumption and assignment of certain executory contracts (the "IRU Contracts") to Uniti Group Inc. and/or one or more of its affiliates and subsidiaries (collectively, "Uniti").

PLEASE TAKE FURTHER NOTICE THAT pursuant to the Order, the procedures regarding the assumption and assignment of IRU Contracts to be assumed by the Debtors pursuant to section 365(b) of the Bankruptcy Code and assigned pursuant to section 365(f) of the Bankruptcy Code (the "Assumption and Assignment Procedures") were approved.

PLEASE TAKE FURTHER NOTICE THAT pursuant to the Assumption and Assignment Procedures, the Debtors hereby provide notice of the assumption and assignment to Uniti of the contracts listed on **Exhibit A** (the “Assumption and Assignment Schedule”). The following information is listed on the Assumption and Assignment Schedule: (a) the name of the counterparty to the IRU Contract, (b) the title of the IRU Contract, if any, (c) a description of the type of IRU Contract, (d) the date of the IRU Contract, and (e) the Debtors’ good faith estimate of the amount necessary to cure any default arising under the IRU Contract (the “Cure Amount”).

PLEASE TAKE FURTHER NOTICE THAT you are receiving this notice because the Debtors’ records reflect that you are a party to an IRU Contract that is listed on the Assumption and Assignment Schedule. Therefore, you are advised to review carefully the information contained in this notice and the related procedures outlined in the Order.

PLEASE TAKE FURTHER NOTICE THAT the deadline for filing objections to the assumption and assignment of the IRU Contracts is **May 29, 2020, at 4:00 p.m., prevailing Eastern Time** (the “Objection Deadline”). Any objection to the assumption and assignment of IRU Contracts **must**: (a) be in writing; (b) comply with the applicable provisions of the Bankruptcy Rules, the Local Rules, and the Case Management Order; (c) state with specificity the nature of the objection and, if the objection pertains to the estimated Cure Amount, the Cure Amount alleged by the objecting counterparty to be the correct Cure Amount, together with any applicable and appropriate documentation in support thereof; and (d) be filed with the Court (contemporaneously with a proof of service) and served upon the following parties so as to be **actually received** on or before **May 29, 2020, at 4:00 p.m., prevailing Eastern Time**:

PLEASE TAKE FURTHER NOTICE THAT any counterparty to an IRU Contract that fails to object timely to the proposed assumption and assignment or cure amount will be deemed to have assented to such assumption and assignment and cure amount.

PLEASE TAKE FURTHER NOTICE THAT section 365(b)(1) of the Bankruptcy Code requires a chapter 11 debtor to cure, or provide adequate assurance that it will promptly cure, any defaults under executory contracts and unexpired leases at the time of assumption. Accordingly, the Debtors have conducted a thorough review of their books and records and have determined the amounts required to cure defaults, if any, under each IRU Contract listed in **Exhibit A**.

PLEASE TAKE FURTHER NOTICE THAT absent any pending dispute, the monetary amounts required to cure any existing defaults arising under the IRU Contracts identified above will be satisfied, pursuant to section 365(b)(1) of the Bankruptcy Code. In the event of a dispute, however, payment of the cure amount would be made following the entry of a final order(s) resolving the dispute and approving the assumption and assignment. Any objection by a contract counterparty to a proposed assumption and assignment or related amount necessary to cure any default arising under the IRU Contract (the “Cure Amount”) must be filed, served, and actually received by the Debtors on or prior to the Objection Deadline. Any counterparty to an IRU Contract that fails to timely object to the proposed assumption and assignment or Cure Amount will be deemed to have assented to such assumption and assignment or Cure Amount. Such party shall be forever barred and estopped from objecting to the Cure Amount, the assumption and assignment of the IRU Contract, adequate assurance of future performance, the relief requested in the Motion, whether applicable law excuses such counterparty from accepting performance by, or rendering performance to, Uniti for purposes of section 365(c)(1) of the Bankruptcy Code and from asserting any additional cure or other amounts against the Debtors and Uniti, as applicable, with respect to such party’s IRU Contract.

PLEASE TAKE FURTHER NOTICE THAT in the event that the Debtors and the contract counterparty cannot resolve any objection to the Debtors’ estimated Cure Amount, the Debtors shall segregate the disputed amount pending a resolution of the dispute by the Court or mutual agreement by the parties. Any objection that remains unresolved as of the next regularly-scheduled omnibus hearing shall be heard at such omnibus hearing (or at another date fixed by the Court or by mutual agreement of the Debtors and the IRU Contract counterparty).

PLEASE TAKE FURTHER NOTICE THAT no IRU Contract shall be deemed assumed and assigned pursuant to section 365 of the Bankruptcy Code until the later of (i) the Settlement Effective Date and (ii) the date on which all objections to the applicable Cure Amount and/or to the proposed assumption and assignment of such IRU Contract have been resolved and the applicable Cure Amount has been paid or provided to be promptly paid by the Debtors.

PLEASE TAKE FURTHER NOTICE THAT assumption and assignment of an IRU Contract pursuant to the Order shall result in the full release and satisfaction of any claims or defaults, whether monetary or nonmonetary, including defaults of provisions restricting the change in control or ownership interest composition or other bankruptcy-related defaults, arising under any assumed IRU Contract at any time before the date that the IRU Contract is assumed.
