Court having determined that the rejection of the Contracts listed herein is a proper exercise of business judgment and in the best interests of the Debtors' estates and creditors; and good and sufficient cause appearing for the relief granted herein, it is HEREBY ORDERED THAT:

1. The Contracts listed on the schedule attached hereto as **Exhibit 1** and as attached to the Rejection Notice dated June 28, 2019 [Docket No. 736] are rejected under section 365 of the Bankruptcy Code as of the Rejection Date stated in the Rejection Notice.

2. Under the Rejections Procedures Order, proofs of claim for claims arising out of such rejection were due on or before August 12, 2019, which is at least thirty (30) days after the Objection Deadline or such other date as the Debtors and each Contract counterparty have agreed or as the Court may order. IF YOU FAILED TO TIMELY SUBMIT A PROOF OF CLAIM IN THE APPROPRIATE FORM ON OR BEFORE THE DEADLINE SET FORTH HEREIN, YOU ARE FOREVER BARRED, ESTOPPED, AND ENJOINED FROM (A) ASSERTING SUCH CLAIM AGAINST ANY OF THE DEBTORS AND THEIR CHAPTER 11 ESTATES, (B) VOTING ON ANY CHAPTER 11 PLAN OF REORGANIZATION FILED IN THESE CASES ON ACCOUNT OF SUCH CLAIM, AND (C) PARTICIPATING IN ANY DISTRIBUTION IN THE DEBTORS' CHAPTER 11 CASES ON ACCOUNT OF SUCH CLAIM.

3. The Debtors and their notice and claims agent are authorized to take all actions necessary to effectuate the relief granted pursuant to this Order and in accordance with the Rejection Notice.

4. Notice of the Rejection Notice shall be deemed good and sufficient notice, and the requirements of Bankruptcy Rule 6004(a) and the Local Bankruptcy Rules have been satisfied.
