FOURTH INTERIM FEE APPLICATION OF PJT PARTNERS LP AS INVESTMENT BANKER TO THE DEBTORS FOR ALLOWANCE OF COMPENSATION AND REIMBURSEMENT OF OUT-OF-POCKET EXPENSES INCURRED FOR THE PERIOD OF MARCH 1, 2020 THROUGH JUNE 26, 2020

PJT Partners LP ("PJT") respectfully represents as follows:

UNITED STATE BANKRUPTCY COURT

I. Background

- 1. On February 25, 2019 (the "Petition Date"), each of the Debtors filed a voluntary petition for relief under chapter 11 of title 11 of the United States Code, 11 U.S.C. §§ 101 et seq., as amended (the "Bankruptcy Code"). The debtors and debtors-in-possession (collectively, the "Debtors") are operating their businesses and managing their properties as debtors-in-possession pursuant to §§ 1107(a) and 1108 of the Bankruptcy Code.
- 2. On March 26, 2019, the Debtors filed the *Debtors' Application for Entry of an Order* (I) Authorizing the Retention and Employment of PJT Partners LP as Investment Banker Nunc Pro Tunc to the Petition Date and (II) Granting Related Relief [Docket No. 193] (the "Retention Application"), pursuant to which the Debtors sought authority to retain and employ PJT as its investment banker pursuant to the terms of an engagement agreement (the "Engagement")

<u>Agreement</u>") dated February 25, 2019. A copy of the Engagement Agreement was attached to the Retention Application.

- 3. On April 22, 2019, this Court entered the *Order (I) Authorizing the Retention and Employment of PJT Partners LP as Investment Bankers* Nunc Pro Tunc *to the Petition Date and (II) Granting Related Relief* [Docket No. 372] (the "Retention Order") approving the Retention Application and authorizing the retention and employment of PJT effective as of the Petition Date, pursuant to the terms of the Engagement Agreement.
- 4. On April 22, 2019, this Court entered the *Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses for Retained Professionals* [Docket No. 374] establishing procedures for interim compensation and reimbursement of expenses for professionals.
- 5. On June 26, 2020, the Court entered the Findings of Fact, Conclusions of Law and Order Confirming the First Amended Joint Chapter 11 Plan of Reorganization (the "Plan") of Windstream Holdings, Inc. et al., Pursuant to Chapter 11 of the Bankruptcy Code [Docket No. 2243].²
- 6. PJT hereby submits its fourth interim fee application (the "Fourth Interim Fee Application") requesting interim allowance of (a) Monthly Fees (as defined herein) earned for investment banking services rendered by PJT as investment banker to the Debtors, and (b) the reimbursement of out-of-pocket expenses incurred for the period of March 1, 2020 through June 26, 2020 (the "Fourth Interim Period").

² Pursuant to the Plan, following confirmation of the Plan on June 26, 2020, the Debtors shall, without further notice to or action, order or approval of this Court, pay any professional fees related to implementation and consummation of the Plan. As such, PJT is filing this interim fee application in respect of its fees and expenses earned through the confirmation date of June 26, 2020. Given that PJT will not earn its Restructuring Fee or its Capital Raising Fee in respect of the Debtors' exit facility until consummation of the Plan, PJT is not requesting payment of such fees hereunder but will file its final fee application requesting such fees at a later date.

7. Investment banking services and out-of-pocket expenses for which compensation and reimbursement are sought were rendered and incurred by PJT on behalf of the Debtors pursuant to chapter 11 of the Bankruptcy Code.

II. The PJT Engagement

- 8. Pursuant to the Engagement Agreement, PJT was retained to provide some or all of the following services to the Debtors:³
 - (a) assisting in the evaluation of the Debtors' businesses and prospects;
 - (b) assisting in the development of the Debtors' long-term business plan and related financial projections;
 - (c) assisting in the development of financial data and presentations to the Debtors' board of directors, various creditors and other third parties;
 - (d) analyzing the Debtors' financial liquidity and evaluate alternatives to improve such liquidity;
 - (e) analyzing various restructuring scenarios and the potential impact of these scenarios on the recoveries of those stakeholders impacted by the Restructuring;
 - (f) providing strategic advice with regard to a potential Restructuring or refinancing of the Debtors' Obligations;
 - (g) evaluating the Debtors' debt capacity and alternative capital structures;
 - (h) participating in negotiations among the Debtors and their creditors, suppliers, lessors (including, but not limited to, Uniti Group Inc. and its subsidiaries), and other interested parties;
 - (i) valuing securities offered by the Debtors in connection with a Restructuring;
 - (j) advising the Debtors and negotiating with lenders with respect to potential waivers or amendments of various credit facilities;
 - (k) assisting in arranging financing for the Debtors, including debtor-in-possession financing, as requested;
 - (l) providing expert witness testimony concerning any of the subjects encompassed by the other investment banking services; and

- (m) providing such other advisory services as are customarily provided in connection with the analysis and negotiation of a transaction similar to a potential Restructuring, as requested and mutually agreed.
- 9. Pursuant to the Engagement Agreement, as approved by the Retention Order, the Debtors agreed to pay PJT as follows in consideration for the services rendered:⁴
 - (a) Monthly Fees: The Debtors shall pay PJT a monthly advisory fee (the "Monthly Fee") of \$250,000 per month. Fifty percent (50%) of all Monthly Fees paid to PJT in excess of \$1,500,000 shall be credited against the Restructuring Fee (as discussed and defined below).
 - (b) <u>Capital Raising Fee</u>. The Debtors shall pay PJT a capital raising fee (the "<u>Capital Raising Fee</u>") for any financing arranged by PJT Partners, at the Debtors' request, earned upon signing of definitive documentation and payable upon the closing of such capital raise. If access to the financing is limited by orders of this Court, a proportionate fee shall be payable with respect to each available commitment (irrespective of availability blocks, borrowing base, or other similar restrictions). The Capital Raising Fee will be calculated as: (i) 0.5% of the total issuance size for senior debt (including, but not limited to, debtor-in-possession) financing, (ii) 1.5% of the total issuance size for junior debt financing, and (iii) 3.0% of the issuance amount for equity financing. Fifty percent (50%) of all Capital Raising Fees paid to PJT Partners shall be credited against any Restructuring Fee (as defined below) payable under the terms of the Engagement Agreement;
 - (c) Restructuring Fee. The Debtors shall pay PJT a restructuring fee equal to the sum of (a) 0.25% of the principal amount of funded debt outstanding for which the Company or one or more of its subsidiaries or affiliates is the primary obligor or a guarantor thereof as of the date of the Company's petition for protection under Chapter 11; plus (b) with respect to any settlement or other recovery related to the Company's capital leases obligations other than annualized rent savings, including the master lease with Uniti, 0.25% of the value realized by the Company as a result of such settlement or recovery determined in good faith by the Company and PJT Partners; plus (c) 0.50% of the capitalized value of the average annualized rent savings with respect to all capital leases obligations restructured, including the master lease with Uniti, which shall be calculated by dividing (x) the average annual reduction in the amount of lease payments following emergence from Chapter 11 through the earlier of the maturity of (A) the applicable existing lease as of the Effective Date and (B) such restructured lease by (y) ten percent (10%). Notwithstanding the foregoing, (1) the portion of the Restructuring Fee payable under clause (b) above shall not exceed \$5 million in the aggregate and (2) the sum of the Restructuring Fee and the Capital Raising Fees payable to PJT Partners under this Agreement, after giving effect to any

crediting of other fees earned hereunder, shall not exceed \$35 million in the aggregate. Except as otherwise provided herein, a Restructuring shall be deemed to have been consummated upon the consummation of a Chapter 11 plan or any other Restructuring pursuant to an order of the Bankruptcy Court or other applicable court. The capitalized value does not represent PJT Partners' opinion on actual value of the master lease with Uniti.

(d) Expense Reimbursements. The Debtors shall reimburse PJT for all reasonable out-of-pocket expenses incurred during this engagement, including, but not limited to, travel and lodging, direct identifiable data processing, document production, publishing services and communication charges, courier services, working meals, reasonable fees and expenses of PJT's counsel and other necessary expenditures, payable upon rendition of invoices setting forth in reasonable detail the nature and amount of such expenses.

III. Services Provided By PJT During The Fourth Interim Period

- 10. The nature of the work performed by PJT during the Fourth Interim Period included the following:
 - (a) assisting in the evaluation of the Debtor's businesses and prospects;
 - (b) assisting in the development of the Debtor's long-term business plan and related financial projections;
 - (c) assisting in the development of financial data and presentations to the Debtor's Board of Directors, various creditors and other third parties;
 - (d) analyzing various restructuring scenarios and the potential impact of these scenarios on the recoveries of those stakeholders impacted by the Restructuring;
 - (e) providing strategic advice with regard to a restructuring;
 - (f) evaluating the Debtor's debt capacity and alternative capital structures;
 - (g) participating in negotiations among the Debtor and its creditors, suppliers, lessors (including, but not limited to, Uniti Group Inc. and its subsidiaries), and other interested parties;
 - (h) providing testimony with respect to the 9019 settlement, backstop support agreement, and confirmation of the Plan; and
 - (i) providing support and advice to the Company and its counsel in connection with the mediation of certain issues regarding the Uniti Arrangement.⁵

⁵ "Uniti Arrangement" means that certain agreement styled as a Master Lease, dated April 24, 2015 (as amended by that certain Amendment No. 1 to Uniti Arrangement, dated February 12, 2016), among CSL National, LP and the entities set forth on Schedule 1 thereof, as landlord (collectively, "Uniti"), and Windstream Holdings, Inc., as tenant.

IV. The PJT Team

11. The investment banking services set forth above were performed by: Nick Leone, Partner; Rob Friedsam, Partner; Jessica Kearns, Partner; Michael Schlappig, Managing Director; Joseph Fallon, Vice President; Justin Costello, Vice President; Sean Mahoney, Associate; Lou Colagreco, Associate; Mac Levin, Analyst; and Tommaso Angelini, Analyst. Details of the background and experience of these professionals are provided in **Appendix A**.

V. PJT's Request for Compensation and Reimbursement of Out-of-Pocket Expenses

12. For the Fourth Interim Period, PJT seeks interim allowance of (a) Monthly Fees earned in the amount of \$966,666.67, and (b) the reimbursement of out-of-pocket expenses incurred in the amount of \$5,101.28. Although every effort has been made to include all out-of-pocket expenses incurred during the Fourth Interim Period, some out-of-pocket expenses might not be included in this Fourth Interim Fee Application due to delays caused in connection with the accounting and processing of such out-of-pocket expenses. Accordingly, PJT reserves the right to make further application to this Court for allowance of such out-of-pocket expenses incurred during the Fourth Interim Period but not included herein.

13. Invoices detailing the fees earned and out-of-pocket expenses incurred by PJT during the Fourth Interim Period are attached hereto as **Appendix B**. A summary of the fees earned and out-of-pocket expenses incurred during the Fourth Interim Period is outlined below:

14. PJT respectfully submits that the compensation requested for the services rendered by PJT to the Debtors during the Fourth Interim Period is fully justified and reasonable based upon (a) the complexity of the issues presented, (b) the skill necessary to perform the financial advisory services properly, (c) the preclusion of other employment, (d) the customary fees charged to clients in non-bankruptcy situations for similar services rendered, (e) time constraints required by the exigencies of the case, and (f) the experience, reputation and ability of the professionals rendering services.

15. PJT respectfully submits that the services it has rendered to the Debtors have been necessary and in the best interests of the Debtors and the Debtors' estates. PJT respectfully submits that under the criteria normally examined in chapter 11 reorganization cases, the compensation requested by PJT is reasonable in light of the work performed by PJT in connection with these cases.

16. The amount of the compensation sought in this Fourth Interim Fee Application and PJT's billing practices are consistent with market practices in a bankruptcy context. PJT has never billed its clients based on the number of hours expended by its professionals. Accordingly, PJT does not have hourly rates for its professionals, and PJT's professionals generally do not maintain detailed time records of the work performed for its clients. However, in accordance with the Retention Order, PJT has maintained contemporaneous time records in these cases in one-half hour increments. Time records of the 1,395.0 hours expended by PJT professionals in providing investment banking services to the Debtors during the Fourth Interim Period are provided in **Appendix C**.

17. A summary of hours expended by PJT professionals during the Fourth Interim Period is provided below:

- 18. Out-of-pocket expenses incurred by PJT are charged to a client if out-of-pocket expenses are incurred for the client or are otherwise necessary in connection with services rendered for such particular client. PJT does not factor general overhead expenses into any disbursements charged to its clients in connection with chapter 11 cases. PJT has followed its general internal policies with respect to out-of-pocket expenses billed as set forth below, with any exceptions specifically explained.
 - (a) All cross-country airfare charges are based upon coach class rates.
 - (b) With respect to local travel, PJT's general policy enables employees to travel by taxi or, in certain circumstances private car service, to and from meetings while rendering services to a client on a client related matter, for which the client is charged. Further, and primarily for safety reasons, employees are permitted to charge to a client the cost of transportation home if an employee is required to work past 9:00 p.m. on weekdays on client specific matters.
 - (c) PJT's general policy permits its professionals to charge in-office dinner meals to a client after working 3 hours beyond their regularly scheduled workday if an employee is required to provide services to the client during such dinnertime, and to charge in-office meals on the weekend if an employee is required to provide services to a client on the weekend and spends at least 4 hours in the office.
 - (d) The External Research category of expenses includes charges from outside computer/electronic service companies that supply, for a fee, research and/or financial documents to PJT. The services provided by these companies primarily consist of the retrieval of financial documents from regulatory agencies and/or the retrieval of

- research that would not otherwise be available to PJT. The Internal Research category of expenses are the charges for time spent by PJT research staff in operating the computer/electronic terminals related to these computer/electronic service companies.
- (e) The Publishing Services category of expenses includes charges for the production of text-based publications such as research reports and presentations, and printing and binding services.
- 19. All services for which PJT requests compensation were performed for and on behalf of the Debtors and not on behalf of any other person or stakeholder.
- 20. No agreement or understanding exists between PJT and any other entity for the sharing of compensation received or to be received for services rendered in or in connection with these proceedings.

VI. Requested Relief

WHEREFORE, PJT respectfully requests that the Court:

- (a) allow and grant interim approval of (i) PJT's Monthly Fees earned during the Fourth Interim Period in the amount of \$966,666.67, and (ii) the reimbursement of PJT's out-of-pocket expenses incurred in the amount of \$5,101.28 for the Fourth Interim Period;
- (b) authorize and direct Debtors to pay PJT's allowed and unpaid fees, and out-of-pocket expenses incurred during the Fourth Interim Period as follows:
