**ORDER GRANTING DEBTORS' SEVENTH OMNIBUS OBJECTION TO
INSUFFICIENT DOCUMENTATION CLAIMS, LATE-FILED CLAIMS,
SUBSTANTIVELY DUPLICATE CLAIMS, AND CLAIMS TO BE MODIFIED**

Upon the objection (the "Objection")² of the above-captioned debtors and debtors in possession (collectively, the "Debtors") seeking entry of an order (this "Order") disallowing and expunging the claims as identified on Schedules 1, 2, 3, 4, 5, and 6 attached hereto and pursuant to section 502(b) of the Bankruptcy Code, Bankruptcy Rule 3007, and the Objection Procedures Order, all as more fully set forth in the Objection; and upon the Bixler Declaration; and the Court having found that it has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157(a)-(b) and 1334(b) and the *Amended Standing Order of Reference from the United States District Court for the Southern District of New York*, dated February 1, 2012, as a core proceeding pursuant to 28 U.S.C. § 157(b)(2); and venue in this district being proper pursuant to 28 U.S.C. §§ 1408 and 1409; and the Court having found that the Debtors provided appropriate notice of the Objection and the opportunity for a hearing on the Objection under the circumstances; and there being no

objections to the relief granted herein with the exception of the objection of irth Solutions, LLP; and no additional notice being required; and upon the record of the hearing held by the Court on the Objection on August 18, 2020 and all of the proceedings herein; and after due deliberation the Court having determined that the legal and factual bases set forth in the Objection and at the hearing establish good and sufficient cause for the relief granted herein; and such relief being in the best interests of the Debtors' estates and creditors, it is HEREBY ORDERED THAT:

1. The Objection is granted as set forth herein.
2. The Insufficient Documentation Claims listed on **Schedule 1** attached hereto are disallowed and expunged in their entirety.
3. The Late-Filed Claims listed on **Schedule 2** attached hereto are disallowed and expunged in their entirety.
4. The Substantively Duplicate Claims listed in the column labeled "Claims to be Disallowed" on **Schedule 3** attached hereto are disallowed and expunged in their entirety.
5. The Claims to be Modified identified on **Schedules 4, 5, and 6** attached hereto are hereby modified to the amount identified in the corresponding "Amount" sub-column and/or "Priority Status" sub-column within the "Modified Claims" column, as applicable and described in the Objection.
6. The "Remaining Claims" as identified on **Schedule 3** and the "Modified Claims" as identified on **Schedules 4, 5, and 6**, as described above (collectively, the "Surviving Claims") will remain on the claims register, subject to any future objection on any basis, and, with respect to the Remaining Claims identified in row numbers 4, 6, 11, 13, 16-19, 23, and 31 on **Schedule 3**, except a basis that is not permitted pursuant to another order of the Court.

7. The *Creditor, irth Solutions, LLC., Response in Opposition to Debtors Objection to Late Filed Claim (#7002) and Motion for Leave to File Out of Time* [Docket No. 2415] seeking leave to file irth Solutions, LLC's Late-Filed Claim (proof of claim number 7002) after the bar date on excusable neglect grounds is hereby denied for the reasons and findings stated in the Court's bench ruling at the hearing held on August 18, 2020.

8. Kurtzman Carson Consultants LLC, the Debtors' claims and noticing agent, is authorized to update the claims register to reflect the relief granted in this Order.

9. Entry of this Order is without prejudice to the Debtors' right to object to any other claims in these chapter 11 cases or to further object to the claims listed on **Schedules 3, 4, 5, and 6** attached hereto (to the extent they are not disallowed and expunged pursuant to this Order) on any grounds whatsoever at a later date.

10. Each objection to each claim as addressed in the Objection and as identified on **Schedules 1, 2, 3, 4, 5, and 6** attached hereto constitutes a separate contested matter as contemplated in Bankruptcy Rule 9014. This Order shall be deemed a separate order with respect to each claim listed on **Schedules 1, 2, 3, 4, 5, and 6**. Any stay of this Order shall apply only to the contested matter that involves such claim and shall not act to stay the applicability or finality of this Order with respect to the other contested matters covered hereby.

11. Notice of the Objection shall be deemed good and sufficient, and the applicable requirements of the Bankruptcy Rules and Local Bankruptcy Rules have been satisfied

12. The terms and conditions of this Order shall be immediately effective and enforceable upon its entry.

13. The Debtors are authorized to take any and all actions reasonably necessary or appropriate to effectuate the relief granted pursuant to this Order in accordance with the Objection.

14. This Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Order.
