**CERTIFICATE OF NO OBJECTION REGARDING DEBTORS' NOTICE OF
 REJECTION OF CERTAIN EXECUTORY CONTRACTS**

Pursuant to 28 U.S.C. § 1746 and Rule 9075-2 of the Local Bankruptcy Rules for the Southern District of New York (the "Local Bankruptcy Rules") and in accordance with this Court's order approving procedures for the rejection, assumption, or assumption and assignment of executory contracts and unexpired leases and granting related relief (the "Procedures Order") [Docket No. 393], the undersigned counsel for the above-captioned debtors and debtors in possession (the "Debtors") hereby certifies as follows:

1. On July 26, 2019, the Debtors filed their *Notice of Rejection of Certain Executory Contracts* [Docket No. 859] (the "Rejection Notice").

2. Kurtzman Carson Consultants LLC served the Rejection Notice on July 26, 2019 [Docket No. 880].

3. The deadline for parties to object to the Rejection Notice was on August 9, 2019, at 4:00 p.m., prevailing Eastern Time (the “Objection Deadline”), as set forth in the Procedures Order and the Rejection Notice or such other date as the Debtors and each Contract counterparty or other party in interest agreed. Consistent with the Procedures Order and the Rejection Notice, proofs of claim on account of the rejection were due on or before the later of (a) September 9, 2019, which is at least thirty (30) days after the Objection Deadline or (b) such other date as the Debtors and each Contract counterparty agreed or as the Court may order. A counterparty or counterparties to a Contract subject to the Rejection Notice that failed to submit a proof of claim on account of the rejection timely and in the appropriate form on or before the deadline set forth herein resulted in that party or parties being forever barred, estopped, and enjoined from (a) asserting such claim against any of the Debtors and their chapter 11 estates, (b) voting on any chapter 11 plan of reorganization filed in these cases on account of such claim, and (c) participating in any distribution in the Debtors’ chapter 11 cases on account of such claim.

4. The Procedures Order provides that the Debtors shall file a certificate of no objection and proposed order if no objection to the Rejection Notice is filed timely. The Procedures Order and Rejection Notice further state that the rejection of the Contracts subject to the Rejection Notice shall become effective on the Rejection Date set forth therein if no such objection has been made to the Rejection Notice.

5. In accordance with Local Bankruptcy Rule 9075-2, the Debtors are filing this certificate of no objection and proposed order more than forty-eight (48) hours after the Objection Deadline and service of the Rejection Notice, as the Debtors have not received or have otherwise

resolved any objections, responsive pleading, or request for a hearing related to the Rejection Notice.

6. Accordingly, the Debtors respectfully request entry of the Proposed Order attached hereto as **Exhibit A** at the Court's earliest convenience.

if any; and this Court having determined that the legal and factual bases set forth in the certificate of no objection and the Rejection Notice establish just cause for the relief granted herein; and upon all of the proceedings had before this Court; and after due deliberation and sufficient cause appearing therefor, it is HEREBY ORDERED THAT:

1. The Contracts listed on the schedule attached hereto as **Exhibit 1** and as attached to the Rejection Notice dated July 26, 2019 [Docket No. 859] are rejected under section 365 of the Bankruptcy Code as of the Rejection Date set forth in the Rejection Notice.

2. Proofs of Claim arising out of such rejection were due on or before September 9, 2019, which is at least thirty (30) days after the Objection Deadline or such other date as the Debtors and each Contract counterparty have agreed or as the Court may order. IF YOU FAILED TO TIMELY SUBMIT A PROOF OF CLAIM IN THE APPROPRIATE FORM ON OR BEFORE THE DEADLINE SET FORTH HEREIN, YOU ARE FOREVER BARRED, ESTOPPED, AND ENJOINED FROM (A) ASSERTING SUCH CLAIM AGAINST ANY OF THE DEBTORS AND THEIR CHAPTER 11 ESTATES, (B) VOTING ON ANY CHAPTER 11 PLAN OF REORGANIZATION FILED IN THESE CASES ON ACCOUNT OF SUCH CLAIM, AND (C) PARTICIPATING IN ANY DISTRIBUTION IN THE DEBTORS' CHAPTER 11 CASES ON ACCOUNT OF SUCH CLAIM.

3. The Debtors and their notice and claims agent are authorized to take all actions necessary to effectuate the relief granted pursuant to this Order and in accordance with the Rejection Notice.

4. Notice of the Rejection Notice shall be deemed good and sufficient, and the requirements of Bankruptcy Rule 6004(a) and the Local Bankruptcy Rules have been satisfied.

5. Notwithstanding anything to the contrary, the terms and conditions of this Order are immediately effective and enforceable upon its entry.

6. This Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Order.
