Proofs of Claim arising out of such rejection were due on or before October 21, 2019, which is at least thirty (30) days after the Objection Deadline or such other date as the Debtors and each Contract counterparty have agreed or as the Court may order. IF YOU FAILED TO TIMELY SUBMIT A PROOF OF CLAIM IN THE APPROPRIATE FORM ON OR BEFORE THE DEADLINE SET FORTH HEREIN, YOU ARE FOREVER BARRED, ESTOPPED, AND ENJOINED FROM (A) ASSERTING SUCH CLAIM AGAINST ANY OF THE DEBTORS AND THEIR CHAPTER 11 ESTATES, (B) VOTING ON ANY CHAPTER 11 PLAN OF REORGANIZATION FILED IN THESE CASES ON ACCOUNT OF SUCH CLAIM, AND (C) PARTICIPATING IN ANY DISTRIBUTION IN THE DEBTORS' CHAPTER 11 CASES ON ACCOUNT OF SUCH CLAIM.
- 3. The Debtors and their notice and claims agent are authorized to take all actions necessary to effectuate the relief granted pursuant to this Order and in accordance with the Rejection Notice.
