- 2. The No Liability Claims listed on **Schedule 1** attached hereto are disallowed and expunged in their entirety.
- 3. Kurtzman Carson Consultants LLC, the Reorganized Debtors' claims and noticing agent, is authorized to update the claims register to reflect the relief granted in this Order.
- 4. Entry of this Order is without prejudice to the Reorganized Debtors' right to object to any other claims in these chapter 11 cases.
- 5. Each objection to each claim as addressed in the Objection and as identified on **Schedule 1** attached hereto constitutes a separate contested matter as contemplated in Bankruptcy Rule 9014. This Order shall be deemed a separate order with respect to each claim listed on **Schedule 1**. Any stay of this Order shall apply only to the contested matter that involves such claim and shall not act to stay the applicability or finality of this Order with respect to the other contested matters covered hereby.
- 6. The terms and conditions of this Order shall be immediately effective and enforceable upon its entry.
