3. Any holder of a claim against the Debtor arising from the rejection of the Rejected Contracts and Rejected Lease shall file a proof of claim by the later of (i) thirty days from the entry of this order or (ii) any general bar date established in these chapter 11 cases (such later date, the “**Rejection Bar Date**”). All untimely filed proofs of claim arising from the rejection of the Rejected Contracts or Rejected Lease may be forever barred.
4. The Debtors shall (a) provide notice of the Rejection Bar Date to non-Debtor parties to the Rejected Contracts and Rejected Lease by serving by pre-paid, first-class mail, a copy of this Order, within five days after entry hereof, and (b) file proof of service thereof
5. The Debtor’s residual interest in any remaining personal property at the Premises and associated with the rejected Lease is hereby deemed abandoned and, subject to the Buyer not asserting an interest in such personal property, the Landlord may dispose of any such abandoned personal property.
6. Notwithstanding the relief granted in this Order and any actions taken pursuant to such relief, nothing in this Order shall be deemed: (a) an admission as to the validity, priority, or

amount of any particular claim against a Debtor; (b) a waiver of the Debtor's or any other party in interest's right to dispute any particular claim on any grounds, including that the Rejected Contracts were terminated prior the Petition Date; (c) a promise or requirement to pay any particular claim; (d) an implication or admission that any particular claim is of a type specified or defined in this Order or the Motion; (e) a request or authorization to assume any agreement, contract, or lease pursuant to section 365 of the Bankruptcy Code; (f) a waiver or limitation of the Debtor's or any other party in interest's rights under the Bankruptcy Code or any other applicable law; or (g) a concession by the Debtor's or any other party in interest that any liens (contractual, common law, statutory, or otherwise) satisfied pursuant to this Order are valid and the Debtor's and all other parties in interest expressly reserve their rights to contest the extent, validity, or perfection or to seek avoidance of all such liens.

7. Nothing in the Motion or this Order shall be deemed or construed as an approval of an assumption of any contract pursuant to section 365 of the Bankruptcy Code.

8. Notice of the Motion as provided therein shall be deemed good and sufficient notice of such Motion and the requirements of Bankruptcy Rules 6006 and the Local Rules are satisfied by such notice.

9. Notwithstanding Bankruptcy Rule 6004(h), to the extent applicable, the terms and conditions of this Order are immediately effective and enforceable upon its entry.

10. The Debtor is authorized to take all actions necessary to effectuate the relief granted in this Order in accordance with the Motion.

11. This Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Order.
