# LIMITED OBJECTION AND RESERVATION OF RIGHTS OF PATHEON MANUFACTURING SERVICES LLC TO MOTION OF THE DEBTOR FOR ENTRY OF AN ORDER (I) APPROVING ADEQUACY OF DISCLOSURE STATEMENT, (II) APPROVING SOLICITATION AND NOTICE PROCEDURES FOR CONFIRMATION OF THE CHAPTER 11 PLAN OF LIQUIDATION, (III) APPROVING BALLOT AND NOTICE FORMS IN CONNECTION THEREWITH, (IV) SCHEDULING CERTAIN DATES WITH RESPECT THERETO, AND (V) GRANTING RELATED RELIEF

Patheon Manufacturing Services LLC ("<u>Patheon</u>"), by and through its undersigned counsel, hereby submits this limited objection and reservation of rights (this "<u>Limited</u> <u>Objection</u>") to the Debtor's above-referenced Motion [D.I. 183] (the "<u>Solicitation Procedures</u> <u>Motion</u>") and in support thereof states as follows:

1. On September 23, 2022, Patheon raised certain concerns it has with respect to the Debtor's Chapter 11 Plan of Liquidation [D.I. 177] (the "<u>Plan</u>"), its Disclosure Statement [D.I. 179] and the Solicitation Procedures Motion. On September 27, 2022, counsel for Patheon and counsel for the Debtor conferred regarding resolutions of Patheon's concerns and, since then, counsel have exchanged further correspondence in an effort to reach final resolution of Patheon's concerns. However, as of the filing of this Limited Objection, Patheon and the Debtor have not reached final resolution on all points of concern to Patheon and the Debtor has
