CERTIFICATION OF ADAM J. GORMAN WITH RESPECT TO THE TABULATION OF VOTES ON THE CHAPTER 11 PLAN OF LIQUIDATION OF ZOSANO PHARMA CORPORATION

I, Adam J. Gorman, depose and say under the penalty of perjury:

- 1. I am a Director of Corporate Restructuring Services, employed by Kurtzman Carson Consultants LLC ("KCC"), located at 222 N. Pacific Coast Highway, 3rd Floor, El Segundo, California 90245. I am over the age of 18 and not a party to these proceedings.
- 2. I submit this certification (the "<u>Voting Certification</u>") with respect to the solicitation of votes and the tabulation of Ballots cast on the *Chapter 11 Plan of Liquidation of Zosano Pharma Corporation* [Docket No. 232] (as may be amended, supplemented, or modified from time to time, the "<u>Plan</u>"). Except as otherwise noted, all facts set forth herein are based on my personal knowledge, knowledge that I acquired from individuals under my supervision, and my review of relevant documents. I am authorized to submit this Voting Certification on behalf of KCC. If I were called to testify, I could and would testify competently as to the facts set forth herein.

3. The Court authorized the retention of KCC (i) as the claims and noticing agent to the Debtor pursuant to the *Order Authorizing the Employment and Retention of Kurtzman Carson Consultants LLC as Claims and Noticing Agent Effective as of the Petition Date* [Docket No. 23] entered on June 6, 2022, and (ii) as administrative advisor to the Debtor pursuant to the *Order Authorizing the Debtor to Employ and Retain Kurtzman Carson Consultants LLC as Administrative Advisor Effective as of the Petition Date* [Docket No. 102] entered on June 30, 2022 (collectively, the "Retention Orders"). The Retention Orders authorize KCC to assist the Debtor with, among other things, the service of solicitation materials and tabulation of votes cast to accept or reject the Plan. KCC and its employees have considerable experience in soliciting and tabulating votes to accept or reject proposed chapter 11 plans.

A. Service and Transmittal of Solicitation Packages and Related Information

4. On October 7, 2022, the Court entered the *Order (I) Approving Adequacy of Disclosure Statement, (II) Approving Solicitation and Notice Procedures for Confirmation of the Debtor's Plan of Liquidation, (III) Approving Ballots and Notice Forms in Connection Therewith, (IV) Scheduling Certain Dates with Respect Thereto, and (V) Granting Related Relief* [Docket No. 227] (the "Disclosure Statement Order").² The Disclosure Statement Order established, among other things, (i) October 6, 2022 as the record date (the "Voting Record Date") for determining the Holders of Claims and Interests entitled to vote on the Plan, (ii) procedures for the solicitation of votes to accept or reject the Plan (the "Solicitation Procedures") and (iii) procedures for the tabulation of Ballots (the "Tabulation Procedures"). Pursuant to the Plan and the Solicitation Procedures, only Holders of Claims as of the Voting Record Date in Class 3 (General Unsecured

Capitalized terms used but not otherwise defined herein shall have the same meanings ascribed to them in the Solicitation Procedures Order.

Claims) and Class 4 (Subordinated Claims) (collectively, the "<u>Voting Classes</u>") were entitled to vote to accept or reject the Plan.

- 5. In accordance with the Disclosure Statement Order, on October 13, 2022, KCC caused to be served (i) the Confirmation Hearing Notice on the parties listed in the creditor matrix and all other parties entitled to receive such notice pursuant to the Disclosure Statement Order, (ii) the Solicitation Packages on all Holders of Claims in the Voting Classes entitled to vote as of the Voting Record Date, (iii) the applicable Non-Voting Status Notice in lieu of Solicitation Packages to the holders of Claims and Interests in the following Classes (which were not entitled to vote on the Plan): Class 1 (Secured Claims), Class 2 (Other Priority Claims), Class 5 (Interests in the Debtor), as well as holders of Claims that are subject to a pending objection. KCC filed the Certificate of Mailing of Claims Agent re: Solicitation Materials [Docket No. 246] on October 20, 2022 evidencing the foregoing.
- 6. On or before October 13, 2022, KCC also posted links to the electronic versions of the solicitation materials, including the Confirmation Hearing Notice, Plan, Disclosure Statement, Disclosure Statement Order, and Cover Letter to All Holders of Claims Entitled to Vote on the Plan on the public access website at www.kccllc.net/ZosanoPharma.
- 7. On or before October 25, 2022, KCC caused to be served supplemental Solicitation Packages on Holders of Claims entitled to vote. KCC filed the *Supplemental Certificate of Mailing of Claims Agent re: Solicitation Materials* [Docket No.253] on November 1, 2022 evidencing the foregoing.

B. Voting and Tabulation Process

8. The Disclosure Statement Order established October 6, 2022 as the Voting Record Date. Pursuant to the Disclosure Statement Order, Holders of Claims in Class 3 (General

Unsecured Claims) and Class 4 (Subordinated Claims) were entitled to vote to accept or reject the Plan. No other classes were entitled to vote on the Plan.

- 9. Pursuant to the Disclosure Statement Order, KCC relied on the Debtors' Schedules of Assets and Liabilities and the Claims information reflected in KCC's CaseView system ("<u>CaseView</u>")³ to identify and solicit Holders of Claims in the Voting Class.
- 10. Using the information outlined above, and with specific guidance from Debtors' counsel, KCC created a voting database reflecting the names and addresses, classification and voting amounts of Holders of Claims in the Voting Class. Specifically, using its CaseView system and voting database, KCC generated Ballots for Holders of Claims entitled to vote to accept or reject the Plan.
- 11. The Disclosure Statement Order established November 10, 2022 at 4:00 p.m. (prevailing Eastern Time) as the deadline by which Ballots for accepting or rejecting the Plan had to be actually received by KCC in order to be counted (the "<u>Voting Deadline</u>").
- 12. In accordance with the Disclosure Statement Order, KCC received and tabulated the Ballots as follows: (a) each returned paper Ballot was opened and inspected at KCC's office; (b) paper Ballots were date-stamped and scanned into KCC CaseView; (c) each electronic Ballot was electronically received and processed; and (d) all Ballots received on or before the Voting Deadline were then entered into KCC CaseView and tabulated in accordance with the Voting and Tabulation Procedures.

13. The final tabulation of votes cast by timely and properly completed Ballots received by KCC is set forth below and attached hereto as **Exhibit A**, with a detailed ballot report for the Voting Class attached hereto as **Exhibit A-1**.

14. In addition, in accordance with the Solicitation and Voting Procedures, KCC reviewed and tabulated the elections recorded on the opt-out forms received by the Voting Deadline from holders of Claims or Interests entitled to opt out of the Plan's Third-Party Release. A report of any such holders that checked the opt-out box on their ballots or opt-out forms is attached hereto as **Exhibit B**. For the avoidance of doubt, this Certification does not certify the validity or enforceability of any opt-out elections received and reported on **Exhibit B** hereto, but rather this Certification is providing such information for reporting and informational purposes.

C. Ballots That Were Not Counted

15. Attached as **Exhibit C** is a detailed report of any Ballots that were not included in the tabulation above because they did not satisfy the requirements for a valid Ballot as set forth in the Disclosure Statement Order for the reasons described therein.

D. Conclusion

16. To the best of my knowledge, information and belief, the foregoing information concerning the distribution, submission, and tabulation of Ballots in connection with the Plan is
