TO THE HONORABLE SANDRA KLEIN, UNITED STATES BANKRUPTCY JUDGE,
THE DEBTORS, AND ALL OTHER PARTIES ENTITLED TO NOTICE:

This Stipulation (the "Stipulation") is entered into by the United States Trustee (the "U.S. Trustee"), Howard M. Ehrenberg, in his capacity as chapter 11 trustee in the above-captioned chapter 11 cases (the "Trustee"), U.S. Bank Trust Company, National Association as Master



1 Trustee (“Master Trustee”), Triple P RTS, LLC and Triple P Securities, LLC (collectively, “TPS”),
2 Sheppard Mullin Richter & Hampton, LLP (“Sheppard”), Dentons US LLP (“Dentons”), Sills
3 Cummis & Gross PC (“Sills”), Province, LLP (“Province”), Orrick Herrington & Sutcliffe LLP
4 (“Orrick”) and Colliers International Greater Los Angeles (“Colliers”). In support of this
5 Stipulation, the Parties recite as follows:

6
7 **RECITALS**

- 8 A. On May 19, 2023, the above-captioned debtors (the “Debtors”) filed their Debtors’
9 Notice of Application and Application Seeking an Order Authorizing the Retention and
10 Employment of Triple P Securities, LLC as Investment Banker to the Debtors and
11 Debtors in Possession Pursuant to 11 U.S.C. §§ 327(a) and 328 Effective as of April 19,
12 2023 [Docket No. 280] (the “TPS Application”).
- 13 B. On September 6, 2023, the Debtors filed three interim fee applications requesting that
14 the Court allow and award compensation and reimbursement of expenses, on an interim
15 basis, to the Debtors’ general bankruptcy counsel, Sheppard, their special and conflicts
16 counsel, Orrick, and their restructuring advisor, Triple P RTS (collectively, the
17 “Debtors’ Professionals’ Fee Applications”), under Section 331 of Title 11 of the United
18 States Code (“Bankruptcy Code”).
- 19 C. On September 6, 2023, the Debtors’ real estate broker, Colliers, filed an interim fee
20 application requesting that the Court allow and award compensation and reimbursement
21 of expenses to Colliers (the “Colliers’ Fee Application”): under Section 331 of the
22 Bankruptcy Code.
- 23 D. On September 6, 2023, the Official Committee of Unsecured Creditors (the
24 “Committee”) in the above-captioned chapter 11 case filed 3 interim fee applications for
25 the Committee’s co-counsels Dentons and Sills and its financial advisor, Province

1 (collectively, the “Committee’s Professionals’ Fee Applications”) under Section 331 of
2 the Bankruptcy Code.

3
4 E. On September 13, the Court entered an Order Directing the Appointment of a Chapter
5 11 Trustee and Setting Hearing and Briefing Schedule on Fee Applications (Doc. No.
6 803) (the “Scheduling Order”). Pursuant to the Scheduling Order, the hearings on the
7 Debtors’ Professionals’ Fee Applications, the Colliers’ Fee Application and the
8 Committee’s Professionals’ Fee Applications (collectively the “Fee Applications”), the
9 hearings on the Fee Applications were continued to January 10, 2024 at 9:00 a.m. with
10 oppositions to the applications due November 22, 2023 and replies, if any, due
11 December 13, 2023.

12 F. On September 15, 2023, the U.S. Trustee filed the Notice of Appointment of Howard M.
13 Ehrenberg as Chapter 11 Trustee (Doc. No. 811) thereby appointing Howard M.
14 Ehrenberg as trustee for the Debtors.

15 G. On October 30, 2023, the Court entered its Order Assigning Matter to Mediation
16 Program and Appointing Mediator and Alternate Mediator in the adversary proceeding
17 (the “Adversary Proceeding”) filed by the Committee against the Master Trustee.
18

19 H. On November 9, 2023, the Court entered its Order Approving Stipulation to Continue
20 Hearing on Multiple Fee Applications (Doc. No. 865), whereby the hearings on the Fee
21 Applications were further continued to February 14, 2024 at 10:00 a.m., with objections
22 due on January 17, 2024 and replies, if any, due on January 31, 2024. The hearing dates
23 in respect of the TPS Application have tracked with such dates applicable to the Fee
24 Applications.

25 I. On March 8, 2024, a mediation was conducted in the Adversary Proceeding. The matter
26 did not settle.
27

1 J. On March 14, 2024, the U.S. Trustee requested that the professionals agree to a further
2 continuance of the hearing on the Fee Applications as a result of the press of other
3 business. On March 19, 2024, the professionals agreed to postpone the hearing on the
4 Fee Applications, and the related objection and reply deadlines, for approximately 30
5 days, to June 12, 2024.

6 K. On March 20, 2024, counsel to the Master Trustee and TPS met and conferred
7 concerning matters associated with the TPS Application and have agreed that if TPS
8 chooses, on or before April 17, 2024, it may file a brief with the Court seeking to
9 establish whether counsel to TPS may effectively appear (as a party in interest or
10 through intervention) at the hearing on the TPS Application (anticipated to be June 12,
11 2024 or such other date as the Court sets to take up the matter of the Fee Applications)
12 in order to present arguments and evidence at such hearing (the "Standing Brief"). The
13 Master Trustee may file a response to any Standing Brief on or before April 26, and TPS
14 may file and Reply on or before May 1. The Master Trustee and TPS request that May 8
15 be reserved for a hearing on Standing Brief.

16
17 L. Therefore, the U.S. Trustee, the Master Trustee, the professionals with pending Fee
18 Applications and the TPS Application and the Chapter 11 Trustee request that the
19 hearings on the Fee Applications and the TPS Application and the related deadlines for
20 objections and replies, if any, be continued for an additional thirty days.

21 **ACCORDINGLY, AND SUBJECT TO THIS COURT'S APPROVAL, IT IS HEREBY**
22 **STIPULATED THAT:**

- 24 1. Any Standing Brief TPS decides to file must be filed on or before April 17, 2024;

26 2. Any responses to the Standing Brief must be filed on or before April 26, 2024;

28 3. Any reply in support of the Standing Brief must be filed on or before May 1, 2024;

1 4. Any objections to the Fee Applications (the "Objections") must be filed on or before
2 April 26, 2024;

4 5. The hearing on the Standing Brief will be on May 8, 2024 and 10:00 a.m.;

5 6. Replies to Objections, if any, must be filed on or before May 24, 2024; and

6 7. The hearing on the Fee Applications and the TPS Application will be on June 12, 2024
7 at 10:00 a.m., or such other date and time convenient to the Court.


