



At the above referenced date, time and location, the Court held an emergency hearing on Debtor's Emergency First Day Motion for Entry of an Order Setting Insider Compensation; Memorandum Of Points And Authorities In Support Thereof (the "Emergency Motion") [Docket No. 12] filed by Borrego Community Health Foundation (capitalized terms not otherwise defined herein have the meanings ascribed to them in the Emergency Motion., the Debtor and Debtor in Possession in the above-captioned chapter 11 bankruptcy case (the "Debtor"). Having considered the Lee Declarations and the arguments of counsel on the record; and the Court having found that the relief requested in the Motion is in the best interests of the Debtor's estate, its creditors, and other parties in interest and necessary to avoid immediate and irreparable harm pursuant to Bankruptcy Rule 6003; and the Court having found that the Debtor provided appropriate notice of the Motion and the opportunity for a hearing on the Motion under the circumstances,

IT IS HEREBY ORDERED THAT:

1. The Motion is granted on an interim basis.
2. The Debtor is immediately authorized to pay Insiders their prepetition salaries in the ordinary course of business.
3. The Court shall hold a continued hearing on the Motion on Tuesday, September 27, 2022, at 3:00 p.m., which the Debtors shall provide notice thereof.
4. The Debtors shall file a supplemental declaration in support of the Motion no later than Monday, September 19, 2022.
5. Any opposition to the Motion shall be filed on or before Monday, September 26, 2022.
6. The Debtor is authorized to take all actions necessary to effectuate the relief granted in this Order in accordance with the Motion.
7. This Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Order.
8. This Order is entered without prejudice to the United States Trustee and any official committee of unsecured creditors, which shall retain the right to raise any issue with the Court, if any.
