BETA's objection is limited to the proposed 3 assumption and assignment of certain contracts in connection with the sale. 4 Debtor has three contracts with BETARMA¹: Healthcare Entity Comprehensive Liability 5 Coverage Contract, No. HCL-22-1052, with a termination date of July 1, 2023; Workers 6 Compensation and Employers Liability Coverage, No. WC-22-1052, with a termination date of July 7 1, 2023; and Auto Liability and Physical Damage Coverage Contract No. AL-22-1052, with a 8 9 termination date of July 1, 2023 (collectively the "BETARMA Contracts").
