ORDER GRANTING COMPLEX <u>CHAPTER 11 BANKRUPTCY CASE TREATMENT</u> (Docket No. 3)

- b. Local District Court Civil Rule 83.1 applies.
- c. Appendix A to the Local Rules of the District Court applies.
