ORDER GRANTING REORGANIZED DEBTORS' SIXTH MOTION FOR ENTRY OF AN ORDER EXTENDING THE TIME TO FILE AND SERVE OBJECTIONS TO CLAIMS [Relates to Docket No. 176]

The Court has considered the Reorganized Debtors' Sixth Motion for Entry of an Order Extending the Time to File and Serve Objections to Claims (the "Motion")³ filed by the abovecaptioned reorganized debtors (collectively, the "Reorganized Debtors").

It is **HEREBY ORDERED THAT**:

- The Claims Objection Deadline is hereby extended to December 31, 2024. 1.
- 2. This Order is without prejudice to the rights of the Reorganized Debtors to seek further extension of the Claims Objection Deadline.

- 5. This Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Order.
