PLEASE TAKE NOTICE that on August 8, 2018, the United States Bankruptcy Court for the Southern District of Texas, Houston Division, entered the Order (A) Authorizing and Scheduling an Auction for the Sale of the Debtors' Assets and (B) Approving Auction and Bid Procedures, Including Payment of Bid Protections (the "Bid Procedures Order") [Docket No. 203]. The Bid Procedures Order, among other things, requires the Debtors to file and serve a notice (the "Cure Notice") of proposed cure amounts (the "Cure Amount") for all contracts and leases subject to assumption and assignment to the successful bidder to be identified at the conclusion of the auction of the Debtors' assets.

**PLEASE TAKE FURTHER NOTICE** that attached hereto as **Exhibits A and B** are amended schedules of the executory contracts and unexpired leases that may be included as part of the sale of the Debtors' Houston and non-Houston locations, respectively, and the proposed Cure Amount for each such lease or contract.

PLEASE TAKE FURTHER NOTICE that any objection to the Cure Amount must be filed with the Bankruptcy Court and served on the undersigned counsel on or before **August 23**, **2018** (the "Cure Objection Deadline").

PLEASE TAKE FURTHER NOTICE that pursuant to the Bid Procedures Order, any objection to the Cure Amount must state with specificity what cure the non-debtor party to the executory contract or unexpired lease believes is required with appropriate documentation in support thereof. If no objection is timely received, the Cure Amount set forth in the Cure Notice shall be controlling notwithstanding anything to the contrary in any executory contract, unexpired lease or other document as of the date of the Cure Notice; the non-debtor party to the executory contract or unexpired lease shall be deemed to have stipulated that the Cure Amount set forth in the Cure Notice is correct; the non-debtor party shall be forever barred, estopped and enjoined from asserting or claiming that any additional amounts are due or other defaults exist, that conditions to assignment must be satisfied under such contract or lease or that there is any objection or defense to the assumption and assignment of such contract or lease, including any argument that there exist conditions to assumption and assignment that must be satisfied under such contract or lease or that any required consent to assignment has not been given.

**PLEASE TAKE FURTHER NOTICE** that the inclusion of any contracts or leases on **Exhibits A and B** hereto shall not constitute or be deemed to be a determination or admission by the Debtors that such document is, in fact, an executory contract or unexpired lease within the meaning of the Bankruptcy Code (all rights with respect thereto being expressly reserved).
