SUPPLEMENTAL ORDER (A) APPROVING THE SALE OF DEBTORS' ASSETS FREE AND CLEAR OF ALL LIENS, CLAIMS, ENCUMBRANCES, AND INTERESTS, (B) AUTHORIZING THE ASSUMPTION AND ASSIGNMENT OF EXECUTORY CONTRACTS AND UNEXPIRED LEASES, AND (C) GRANTING RELATED RELIEF

[Relates to Docket No. 20]

The above-referenced debtors and debtors-in-possession (collectively, the "<u>Debtors</u>") filed their motion (the "<u>Motion</u>")<sup>2</sup> for entry of an order (this "<u>Order</u>") approving the sale (the "<u>Sale</u>") of Debtors' assets free and clear of all liens, claims, encumbrances, and interests. (Doc. No. 20). On September 12, 2018, the Court entered its *Order (A) Approving the Sale of Debtors'* Assets Free and Clear of All Liens, Claims, Encumbrances, and Interests, (B) Authorizing the Assumption and Assignment of Executory Contracts and Unexpired Leases, and (C) Granting Related Relief (the "<u>Sale Order</u>"). (Doc. No. 482). Paragraph 10 of the Sale Order provided that final approval of the form of Asset Purchase Agreement between the Debtors and Greater Texas Emergency Center, LLC ("<u>Greater Texas</u>") is deferred pending further order of the Court and scheduled a hearing for September 14, 2018 at 10:00 a.m.

- 1. The Greater Texas Purchase Agreement is hereby approved.
- 2. Notwithstanding anything to the contrary in the Sale Order, the Sale Order applies fully to the Greater Texas Purchase Agreement as if the Sale Order were fully set forth herein.
