

The Court has considered the Liquidating Trusts' Ninth Omnibus Motion for Order (1) Disallowing Claims (Duplicate Claims); (2) Disallowing Claims (Wrong Debtor); and (3) Disallowing Claims (Amended and Superseded Claims) (Docket No. 2841) (the "Objection"), filed on March 3, 2014 by the PC Trusts, by and through the Liquidating Trustee, seeking (among other things) entry of an order reassigning PCFC Claim No. 56 [Debra J. Noble], and the *Amended* Notice of Objection to Claim (Docket No. 2866) (the "Amended Notice") filed on April 10, 2014.<sup>2</sup> The Court considered the Objection, the Amended Notice and all related papers and documents. No timely written opposition was filed in response to the Objection. The Court has jurisdiction over this matter pursuant to sections 157 and 1334 of Title 28 of the United States Code, and the Court finds the form, scope and timing of notice of the Motion was adequate under the circumstances of these cases. // // //
