2 **10:30 a.m.** (the “Hearing”), and will take place at the United States Bankruptcy Court, 1300 Clay
3 Street, Oakland, California, before the Honorable William J. Lafferty, United States Bankruptcy
4 Judge, to consider Certain Underwriters at Lloyd’s, London, subscribing severally and not jointly to
5 Slip Nos. CU 1001 and K 66034 issued to the Roman Catholic Archbishop of San Francisco, and
6 Nos. K 78138 and CU 3061 issued to the Roman Catholic Bishop of Oakland’s (collectively,
7 “London Market Insurers” or “LMI”) *Motion for Protective Order* (“Motion”) filed concurrently
8 herewith by LMI in the above-captioned chapter 11 bankruptcy case.

9 The Motion seeks a protective order pursuant to Fed. R. Civ. P. 26(c) of the Official
10 Committee of Unsecured Creditors’ (“Committee”) subpoena to LMI.

11 The Motion is based upon this Notice, the Motion and the memorandum of points and
12 authorities set forth therein, Declaration of Russell W. Roten, any and all supplemental papers that
13 may be filed by LMI, the papers on file in this bankruptcy case, and on such arguments or evidence

3 listed above. Unless a timely objection is filed, the Court may grant the relief requested in the Motion
4 without a hearing. Failure to file and serve a timely objection may result waiver of any objection.
