**PLEASE TAKE NOTICE THAT** Non-Party, American Home Assurance Company (“American Home”), by and through its undersigned counsel of record, filed a Motion to Quash (the “Motion”) the Official Committee of Unsecured Creditors’ (“Committee”) Subpoena for Rule 2004 Examination (“Subpoena”) on March 4, 2024 (ECF 920). The Motion respectfully moves this Court for an order limiting the Subpoena to documents that are not unduly burdensome or improper in scope.

**PLEASE TAKE FURTHER NOTICE** that a hearing to consider the Motion shall take place on **April 17, 2024 at 10:30 a.m.**, or as soon thereafter as the matter may be heard, before the Honorable William J. Lafferty, United States Bankruptcy Judge, in Courtroom 220, 1300 Clay Street, Oakland, California 94612.

The Motion to Quash is made and based upon the memorandum of points and authorities, the arguments set forth therein, the Declaration of Amy P. Klie, and the exhibits attached thereto, all papers and pleadings on file in this case, Federal Rule of Civil Procedure (the “FRCP”) 45 and any arguments that this Court may allow at the time of the hearing of this matter. Copies of the Motion and papers filed in support thereof, and all pleadings and papers filed in this Bankruptcy Case, can be obtained from the website maintained by the Debtor’s claims and noticing agent, Kurtzman Carson Consultants LLC, at <https://www.kccllc.net/rcbo>.

**PLEASE TAKE FURTHER NOTICE** the Hearing will be held in person in the courtroom, provided that (1) hearings will be held in person but that parties may attend by Zoom Webinar/AT&T Teleconference with prior approval from the Court; (2) additional information is available on Judge Lafferty’s Procedures page on the Court’s website, which is <http://www.canb.uscourts.gov>; and (3) information on how to attend the hearing by Zoom Webinar/AT&T Teleconference will be included with each calendar posted under Judge Lafferty’s Calendar on the court’s website. 2 with Clerk of the Bankruptcy Court at 1300 Clay Street, Suite 300, Oakland, California, 94612  
3 (mailing address: P.O. Box 2070, Oakland, California, 94604) and must be served on counsel for  
4 American Home at the address listed above. Unless a timely objection is filed, the Court may  
5 grant the relief requested in the Motion without a hearing. Failure to file and serve a timely  
6 objection may result waiver of any objection.
