CERTIFICATION OF P. JOSEPH MORROW IV WITH RESPECT TO THE TABULATION OF VOTES ON THE JOINT AMENDED CHAPTER 11 PLAN OF STAGE STORES, INC. AND SPECIALTY RETAILERS, INC.

I, P. Joseph Morrow IV, depose and say under the penalty of perjury:

- 1. I am a Vice President of Corporate Restructuring Services, employed by Kurtzman Carson Consultants LLC ("KCC"), located at 222 N. Pacific Coast Highway, 3rd Floor, El Segundo, California 90245. I am over the age of 18 and not a party to this action.
- 2. On May 11, 2020, the Court entered the *Order Appointing KCC as Claims*, *Noticing, and Solicitation Agent* [Docket No. 49].
- 3. On July 1, 2020, the Court entered the Order Approving (I) the Adequacy of the Disclosure Statement, (II) Solicitation and Notice Procedures, (III) Forms of Ballots and Notices in Connection Therewith, and (IV) Certain Dates with Respect Thereto [Docket No. 540] (the "Disclosure Statement Order")² establishing, among other things, certain solicitation and voting tabulation procedures.

All capitalized terms used but not otherwise defined herein shall have the meanings ascribed to them in the Plan and the Disclosure Statement Order (each as defined below), as applicable.



The Debtors in these chapter 11 cases, along with the last four digits of each Debtor's federal tax identification number, are: Stage Stores, Inc. (6900) and Specialty Retailers, Inc. (1900). The Debtors' service address is: 2425 West Loop South, Houston, Texas 77027.

- 4. KCC worked with the Debtors' advisors to solicit votes to accept or reject the *Joint Amended Chapter 11 Plan of Stage Stores, Inc. and Specialty Retailers, Inc.* [Docket No. 536] (the "Plan") and to tabulate the ballots of creditors voting to accept or reject the Plan.
- 5. KCC has considerable experience in soliciting and tabulating votes to accept or reject proposed chapter 11 plans. Except as otherwise noted, I could and would testify to the following based upon my personal knowledge. I am authorized to submit this Certification on behalf of KCC.

A. Service and Transmittal of Solicitation Packages and Related Information

- 6. On July 3, 2020 (the "Solicitation Launch Date"), KCC caused to be served the Confirmation Hearing Notice on the creditor matrix and all other parties required to receive such notice pursuant to the Disclosure Statement Order. On July 3, 2020 KCC caused to be served Solicitation Packages on all Holders of Claims in Classes 3 and 4 (collectively the "Voting Classes") entitled to vote as of June 30, 2020 (the "Voting Record Date"), and a Non-Voting Status Notice in lieu of a Solicitation Package on all Holders of Unimpaired Claims in Classes 1 and 2, in accordance with the Disclosure Statement Order. A certificate of service evidencing the foregoing was filed with the Bankruptcy Court on July 16, 2020 as Docket No. 595.
- 7. On July 3, 2020, KCC posted links to the electronic versions of the Confirmation Hearing Notice, Plan, Disclosure Statement, and Disclosure Statement Order on the public access website at www.kccllc.net/stagestores.
- 8. On July 7, 2020 the Confirmation Hearing Notice was published in *The New York Times (National Edition)*. An affidavit evidencing the publication of the Confirmation Hearing Notice was filed with the Court on July 7, 2020 [Docket No. 564].

9. Between July 8, 2020 and July 30, 2020, KCC caused to be served supplemental Solicitation Packages, on Holders of Claims entitled to vote who filed claims after the June 30, 2020 Voting Record Date, but on or before the July 24, 2020 (the "Claims Bar Date"). A certificate of service evidencing the foregoing was filed with the Bankruptcy Court on August 5, 2020 as Docket No. 649.

B. The Tabulation Process

- Date and July 1, 2020 through July 24, 2020 as the time periods for determining which Holders of Claims were entitled to receive Solicitation Packages or Non-Voting Packages, as applicable. Pursuant to the Disclosure Statement Order, Holders of Claims in Class 3 (Prepetition Secured Claims) and Class 4 (General Unsecured Claims) were entitled to vote to accept or reject the Plan or opt out of the Plan's third-party releases. No other classes were entitled to vote on the Plan.
- 11. Pursuant to the Disclosure Statement Order, KCC relied on the Debtors' Schedules of Assets and Liabilities and the Claims information pertaining to the Debtors' Chapter 11 Cases, as reflected in KCC's systems, in order to identify the Holders of Claims entitled to vote to accept or reject the Plan.
- 12. Using the information outlined above, and with specific guidance from the Debtors' counsel, KCC created a voting database reflecting the names of Holders in the Voting Classes, addresses of such Holders, voting amounts and classification of Claims in the Voting Classes.
- 13. Using its KCC CaseView voting database ("KCC CaseView"), KCC generated ballots for Holders of Claims entitled to vote to accept or reject the Plan. The Disclosure

Statement Order established August 7, 2020 at 4:00 p.m. (Central Time) as the deadline for receiving ballots to accept or reject the Plan (the "Voting Deadline").

- 14. KCC also relied on a security position report provided by The Depository Trust Company ("DTC") as of the Voting Record Date to identify the bank and brokerage firms (the "Nominees") that hold such Class 7 (Existing Interests) on behalf of underlying beneficial owners. Additionally, KCC received information from Computershare, a stock transfer agent, of the Holders of Class 7 (Existing Interests) that are in direct registration on the Computershare records (the "Registered Holders").
- 15. For Class 7 (Existing Interests), KCC provided Beneficial Holder Opt-Out Packages to the Nominees appearing on the security position report received from DTC, or the Nominees' agents, for subsequent forwarding to the underlying beneficial owners. KCC also provided a Class 7 Master Opt-Out Form to each Nominee for their use in reporting the results of the underlying Beneficial Holder Opt-Out Forms. KCC also provided the Registered Holders with Opt-Out Packages. No Holders of Claims or Interests were identified as Class 8 (Section 510(b) Claims).
- 16. Pursuant to the Disclosure Statement Order, KCC received and tabulated ballots as follows: (a) each returned paper ballot was opened and inspected at KCC's offices; (b) paper ballots were date-stamped and scanned into KCC CaseView; (c) each e-Ballot was electronically received and processed; and (d) all ballots received on or before the Voting Deadline were then entered into KCC CaseView and tabulated in accordance with the tabulation rules outlined in the Disclosure Statement Order.

17. The final tabulation of votes cast by timely and properly completed ballots

received by KCC is attached hereto as Exhibit A. The detailed ballot reports for Voting Classes

3 and 4 are attached to this Certification as Exhibits A-1 and A-2.

18. In addition, in accordance with the Solicitation and Voting Procedures, KCC

reviewed and tabulated the elections recorded on the opt-out forms received by the Voting

Deadline from Holders of Interests entitled to opt out of the Plan's Third-Party Release, or from

the Nominees of such Holders. A report of any such Holders that checked the opt-out box on

their ballots or opt-out forms is attached hereto as Exhibit B. For the avoidance of doubt, this

Certification does not certify the validity or enforceability of any opt-out elections received and

reported on Exhibit B hereto, but rather this Certification is providing such information for

reporting and informational purposes.

C. Ballots That Were Not Counted

19. Attached as Exhibit C to this Certification is a detailed report of any ballots that

were not included in the tabulation above because they did not satisfy the requirements for a

valid ballot as set forth in the Disclosure Statement Order.
