## OBJECTION TO APPROVAL OF THE DISCLOSURE STATEMENT

- I. On November 7, 2023, I received notice via "Legal Mail" of the filing of a "Disclosure Statement" and an "Objection Deadline" (Doc. 1077). To-date I still have not been served the said disclosure statement, or any other related documents.
- II. As an incarcerated individual without legal representation, I have no way to access court documentation and have not been adequately included or informed about the ongoing settlement proceedings related to this case. My involvement in these proceedings is crucial, as my claim against the debtor is based on a significant personal injury matter under Section 1983 in the US District Court for the Middle District of Alabama, in the case styled Benjamin Bedogwar Oryang v. Jefferson Dunn et Al, Civil Action No. 2:21-cv-00023-ECM. That case is currently stayed due to the ongoing bankruptcy proceedings.
- III. I believe that the approval of the Disclosure Statement without addressing these concerns would be prejudicial to my interests and rights as a creditor and, with respect, I request that the Court consider these circumstances and allow for my adequate representation and participation in these proceedings.

WEREFORE, I respectfully request that the Court deny approval of the Disclosure Statement until my concerns are adequately addressed and my participation in these proceedings is ensured.
