MOTION BY CHAPTER 11 TRUSTEE TO APPROVE AMENDED FORM OF NOTICE WITH RESPECT TO TELEPHONIC/INTERNET HEARING ON DISCLOSURE STATEMENT (Expedited Determination Requested)

To the Honorable Melvin S. Hoffman, United States Bankruptcy Judge:

Stephen B. Darr, the duly appointed Chapter 11 trustee (the "Trustee") of the bankruptcy estates of TelexFree, LLC, TelexFree, Inc., and TelexFree Financial, Inc.
