**RESPONSE BY LIQUIDATING TRUSTEE TO  
PARTICIPANT LETTER FILED ON DECEMBER 7, 2023 [DOCKET NO. 3803]**

Stephen B. Darr, the duly appointed Liquidating Trustee (the "Liquidating Trustee") of the reorganized bankruptcy estates of TelexFree, LLC, TelexFree, Inc., and TelexFree Financial, Inc. (collectively, the "Reorganized Debtors" or "TelexFree") respectfully files this response to the letter received by the Court on December 7, 2023 from Jose Alfredo Reyes Santos regarding the status of his claim and distributions thereon. The Liquidating Trustee reports the following:

1. The claimant inquires as to the status of Claim No. 08633-000. This claim has been allowed in the amount of \$7,082.10.
2. An initial distribution was made on this claim. Subsequent distributions were delayed because of correspondence raising concerns about fraudulent activity regarding the claim.
3. The Trustee has since resolved the concerns which inhibited the subsequent distributions.
4. The claimant and the Trustee's disbursement agent, BMC Group, have agreed that the remaining distributions will be made by PayPal. The next set of PayPal distributions is scheduled to occur on December 29, 2023.
