ORDER (A) GRANTING THE DEBTORS AN EXTENSION OF TIME WITHIN WHICH TO FILE SCHEDULES AND RELATED DOCUMENTS AND (B) WAIVING THE REQUIREMENTS TO FILE LISTS OF EQUITY SECURITY HOLDERS <u>AND PROVIDE NOTICE TO EQUITY SECURITY HOLDERS</u>

Upon consideration of the motion (the "<u>Motion</u>")² of the Debtors for entry of an order, pursuant to sections 105(a) and 521 of the Bankruptcy Code and Bankruptcy Rules 1007(a), 1007(c) and 2002(d): (i) extending the time within which the Debtors must file the schedules and statements described in Bankruptcy Rule 1007, including the schedules of assets and liabilities, schedules of executory contracts and unexpired leases and statements of financial affairs (the "<u>Schedules and Statements</u>"); (ii) waiving the requirements to file lists of equity security holders and provide notice to equity security holders; and it appearing that this Court has jurisdiction to consider the Motion pursuant to 28 U.S.C. §§ 157 and 1334; and it appearing that venue of these cases and the Motion in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and it appearing that this matter is a core proceeding pursuant to 28 U.S.C. § 157(b); and it appearing

that adequate and proper notice of the Motion has been given and that no other or further notice need be given; and a hearing having been held to consider the relief requested in the Motion; and upon the record of the hearing and all of the proceedings had before the Court; and the Court having found and determined that the relief sought in the Motion is in the best interests of the Debtors, their estates, their creditors and all other parties in interest; and the legal and factual bases set forth in the Motion having established just cause for the relief granted herein; and after due deliberation and sufficient cause appearing therefor; it is hereby ORDERED that:

1. The Motion is GRANTED to the extent provided herein.

2. The Debtors are granted an extension of the deadline to file their Schedules and Statements through and including August 28, 2015, without prejudice to the Debtors' rights to seek further extensions or waivers.

3. The requirement under Bankruptcy Rule 1007(a)(3) that the Debtors file lists of equity security holders is hereby waived.

4. The requirement under Bankruptcy Rule 2002(d) that the Debtors provide notice to all equity security holders of the Chapter 11 Cases is hereby waived.

5. This Court shall retain jurisdiction with respect to all matters arising from or related to the implementation or interpretation of this Order.
