# NOTICE OF DEBTORS' INTENT TO WITHDRAW REMAINING FUNDS FROM UTILITY DEPOSIT ACCOUNT

PLEASE TAKE NOTICE that, on October 22, 2018, the above-captioned debtors and debtors in possession (collectively, the "Debtors") filed that certain *Debtors' Motion for Interim and Final Orders, Pursuant to Sections 105(a) and 366 of the Bankruptcy Code, (I) Prohibiting Utility Companies from Altering, Refusing, or Discontinuing Utility Services, (II) Deeming Utility Companies Adequately Assured of Future Payment, (III) Establishing Procedures for Determining Additional Adequate Assurance of Payment, and (IV) Setting a Final Hearing Related Thereto [Docket No. 6] (the "Utility Motion"). On November 15, 2018, the Court entered an order granting the relief requested in the Utility Motion on a final basis [Docket No. 237] (the "Final Utility Order").<sup>2</sup>* 

**PLEASE TAKE FURTHER NOTICE** that, pursuant to paragraph 8 of the Final Utility Order, because the related accounts have become Closed Accounts, the Debtors hereby provide notice of their intent to withdraw all of the remaining funds from the Utility Deposit Account except those amounts set forth on **Exhibit 1** attached hereto.

**PLEASE TAKE FURTHER NOTICE** that responses to this Notice, if any, must be directed to the Debtors' undersigned counsel, to the attention of Betsy L. Feldman, Esq., at the address for counsel set forth below and at bfeldman@ycst.com, so as to be received within seven (7) days of the filing of this Notice. Pursuant to the Final Utility Order, if any Utility Company fails to respond to this Notice as provided herein, without further notice or a hearing and without the need for any further order of the Court, the Debtors are authorized to withdraw from the Utility Deposit Account the funds related to such Utility Company except, as applicable, those amounts set forth on **Exhibit 1** attached hereto.
