DECLARATION OF DAVID HARTIE REGARDING THE SOLICITATION AND TABULATION OF VOTES ON THE FIRST AMENDED JOINT CHAPTER 11 PLAN OF REORGANIZATION OF WINDSTREAM HOLDINGS, INC. ET AL., PURSUANT TO CHAPTER 11 OF THE BANKRUPTCY CODE

I, David Hartie, declare under the penalty of perjury that the following is true and correct to the best of my knowledge, information, and belief:

- 1. I am the Managing Director, Public Securities Services, employed by Kurtzman Carson Consultants LLC ("KCC"), whose main business address is 222 N. Pacific Coast Highway, 3rd Floor, El Segundo, California 90245. I am over the age of 18 and am not individually a party to these proceedings.
- Adam Gorman, Senior Managing Consultant, assisted in the service and 2. tabulation described herein.
- I submit this declaration (the "Voting Certification") with respect to the 3. solicitation and tabulation of votes cast on the First Amended Joint Chapter 11 Plan of Reorganization of Windstream Holdings, Inc., et al., Pursuant to Chapter 11 of the Bankruptcy

The last four digits of Debtor Windstream Holdings, Inc.'s tax identification number are 7717. Due to the large number of Debtors in these chapter 11 cases, for which joint administration has been granted, a complete list of the debtor entities and the last four digits of their federal tax identification numbers is not provided herein. A complete list of such information may be obtained on the website of the Debtors' claims and noticing agent at http://www.kccllc.net/windstream. The location of the Debtors' service address for purposes of these chapter 11 cases is: 4001 North Rodney Parham Road, Little Rock, Arkansas 72212.



Code [Docket No. 1781] (as amended, modified, or supplemented, the <u>Plan</u>").<sup>2</sup> Except as otherwise indicated herein, all facts set forth herein are based upon my personal knowledge or my review of relevant documents. I am authorized to submit this Voting Certification on behalf of KCC. If I were called upon to testify, I could and would testify competently as to the facts set forth herein.

- 4. The Court authorized the retention of KCC as the Voting and Claims Agent for the Debtors pursuant to the *Order Authorizing Retention and Appointment of Kurtzman Carson Consultants LLC as Claims and Noticing Agent* [Docket No. 59] and the *Order Authorizing the Debtors to Employ and Retain Kurtzman Carson Consultants LLC as Administrative Advisor Effective* Nunc Pro Tunc *to the Petition Date* [Docket No. 371].
- 5. On May 14, 2020, the Court entered the Order Approving (I) Disclosure Statement, (II) Solicitation and Notice Procedures, (III) Forms of Ballots and Notices in Connection Therewith, and (IV) Certain Dates with Respect Thereto [Docket No. 1814] (the "Disclosure Statement Order") pursuant to which the Court, among other things, (a) authorized the Debtors to solicit acceptances for the votes to accept or reject the First Amended Joint Chapter 11 Plan of Reorganization of Windstream Holdings, Inc., et al., Pursuant to Chapter 11 of the Bankruptcy Code [Docket No. 1781] (as amended, modified, or supplemented, the "Plan"), (b) approved procedures for soliciting, receiving and tabulating votes on the Plan (the "Solicitation and Voting Procedures"); and (c) approved the Disclosure Statement for the First Amended Joint Chapter 11 Plan of Reorganization of Windstream Holdings, Inc., et al., Pursuant to Chapter 11 of the Bankruptcy Code [Docket No. 1813] (the "Disclosure Statement").

Capitalized terms used but not otherwise defined herein shall have the meanings set forth in the Plan or the Disclosure Statement Order (as defined herein).

- 6. Pursuant to the Disclosure Statement Order, KCC worked with the Debtors and their counsel to solicit votes to accept or reject the Plan and to tabulate the ballots of creditors voting to accept or reject the Plan.
- 7. KCC has considerable experience in soliciting and tabulating votes to accept or reject proposed plans of reorganization, and I am duly authorized to make and submit this Certification on behalf of KCC regarding the tabulation of votes on the Plan. Except as otherwise indicated, all matters set forth herein are based upon my personal knowledge.

#### A. Service and Transmittal of Solicitation Packages and Related Information.

- 8. Pursuant to the Disclosure Statement Order and in accordance with the Solicitation and Voting Procedures, on or before May 18, 2020, KCC caused to be served the Solicitation Packages, notices and other solicitation materials in accordance with the Disclosure Statement Order. An affidavit of service evidencing the service of the foregoing was filed with the Court on May 14, 2020 [Docket No. 1842].
- 9. Throughout the course of the voting period, KCC forwarded Solicitation Packages to creditors whose packages were returned with a forwarding address. KCC filed supplemental affidavits of service on June 15, 2020 [Docket Nos. 2037 and 2038] setting forth the service of forwarded Solicitation Packages.
- 10. In addition, copies of the Disclosure Statement Order and the Disclosure Statement have been available, free of charge, at <a href="http://www.kccllc.net/windstream">http://www.kccllc.net/windstream</a> (the "KCC Website").

#### **B.** The Tabulation Process.

11. The Disclosure Statement Order established May 7, 2020 as the Voting Record Date for determining which creditors and holders of interests were entitled to receive the

Solicitation Packages and, where applicable, vote on the Plan. Pursuant to the Disclosure Statement Order, holders of Claims and Interests in each of the following Classes were entitled to vote to accept or reject the Plan (collectively, the "<u>Voting Classes</u>"). No other Classes were entitled to vote to accept or reject the Plan.<sup>3</sup>

Class 3	First Lien Claims
Class 4	Midwest Notes Claims
Class 5	Second Lien Claims
Class 6A	Obligor General Unsecured Claims

- 12. Pursuant to the Disclosure Statement Order, KCC relied on the Debtors' Schedules of Assets and Liabilities and the Claims information reflected in KCC's CaseView<sup>4</sup> ("CaseView") system, along with records provided by Cortland Capital Markets Services LLC, as agent to the Credit Agreement, to identify and solicit holders of Claims and Interests in the Voting Classes. KCC was instructed by the Debtors to solicit, review, determine the validity of, and tabulate Ballots submitted to vote to accept or reject the Plan by the holders of Claims in the Voting Classes.
- 13. Pursuant to the Disclosure Statement, KCC relied on a security position report provided by the Depository Trust Company ("<u>DTC</u>") to identify and solicit holders of Class 3 First Lien Claims derived from or based upon the First Lien Notes Indenture, Class 4 Midwest

Notes Claims, Class 5 Second Lien Claims, and Class 6A Unsecured Note Claims (Together the "Notes Claims") entitled to vote to accept or reject the Plan.

- 14. Using the information outlined above, and with specific guidance from the Debtors' counsel and financial advisors, KCC created a voting database reflecting the names and addresses of holders of Claims and Interests, the classification of Claims and Interests, and voting amounts in the Voting Classes. Specifically, using its CaseView system and voting database, KCC generated Ballots for holders of Claims entitled to vote to accept or reject the Plan.
- 15. The Disclosure Statement Order established June 17, 2020, at 4:00 p.m. (prevailing Eastern Time) as the deadline by which Ballots for accepting or rejecting the Plan submitted by persons other than Governmental Units had to be actually received by KCC in order to be counted (the "Voting Deadline").
- 16. Pursuant to the Disclosure Statement Order, KCC received and tabulated the Ballots submitted by holders of Claims and Interests in the Voting Classes as follows: (a) each returned paper Ballot was opened and inspected at KCC's office; (b) each returned paper Ballot was date-stamped, sorted according to its Class, and scanned into the CaseView system; (c) each e-Ballot was electronically received and processed; and (d) all Ballots received on or before the Voting Deadline was entered into the CaseView system, or in the case of Notes Claims Master Ballots, tabulated against the security position amounts appearing for each Nominee as listed on the security position reports received from DTC, and tabulated in accordance with the tabulation rules outlined in the Disclosure Statement Order.
- 17. The final voting results with respect to the Voting Classes for the Plan, which includes a breakdown of the voting results on an aggregate basis, is attached as **Exhibit A**.
