1 Astria Health (“Astria”) and SHC Medical Center - Yakima, both Washington  
2 nonprofit corporations, doing business as Astria Regional Medical Center  
3 (“ARMC”), along with the above-referenced affiliated debtors (collectively, the  
4 “Debtors”), the debtors and debtors in possession in the above-captioned chapter 11  
5 bankruptcy cases (collectively, the “Chapter 11 Cases”), hereby file this limited  
6 response (the “Response”) to the *Motion For Allowance Of Administrative Expense*  
7 *Claim Pursuant To 11 U.S.C. § 503(a) And (b) And Payment Thereof And Notice*  
8 [Docket No. 1528] (the “Request”) filed by Timothy B. Icenogle (“Dr. Icenogle”).  
9 In his Request, Dr. seeks allowance of his administrative expense claim “for post-  
10 petition compensation of \$53,000.00 and ‘tail’ insurance coverage or the cost thereof  
11 estimated to be \$134,193.00, due and owing to Dr. Icenogle pursuant to the terms of  
12 the Provider Employment Agreement between Dr. Icenogle and the Astria Regional  
13 Medical Center (‘Astria’) dated June 29, 2019 (the ‘Employment Agreement’).”  
14 Request at 1. The Debtors are willing to stipulate (a) to a total payment of \$53,000.00  
15 as postpetition compensation for the notice period under the Employment  
16 Agreement, and (b) to provide “tail” coverage organizationally, such that Dr.  
17 Icenogle will be covered. Therefore, the Debtors do not object to the Request,  
18 *provided that* the Debtors are allowed to pay this amount at confirmation of a plan of  
19 reorganization, pursuant to 11 U.S.C. § 1129(a). The Debtors understand this  
20 resolution of the Request is acceptable to Dr. Icenogle.
