STIPULATION

This stipulation (the “Stipulation”) is entered into between Astria Health (“Astria”), a Washington nonprofit corporation, along with the above-referenced affiliated debtors (collectively, the “Debtors”), the debtors and debtors in possession in the above-captioned chapter 11 bankruptcy cases (collectively, the “Chapter 11 Cases”), and Cerner Corporation, on behalf of itself and its affiliates (collectively, “Cerner” and together with the Debtors, the “Parties”).

RECITALS

1. The Debtors filed voluntary petitions for relief under chapter 11 of title 11 of the United States Code, 11 U.S.C. §§ 101, *et seq.* on May 6, 2019.
2. On July 22, 2020, Cerner filed the *Request for Allowance and Payment of Administrative Expense Claim of Cerner Corporation* [Docket No. 1573] (the “Cerner Admin Claim”). On July 22, 2020, Cerner filed the *Notice Of Request for Allowance and Payment of Administrative Expense Claim of Cerner Corporation* [Docket No. 1574], which set August 17, 2020 as the deadline to object to the C Admin Claim (the “Reply Deadline”).
3. By order entered August 18, 2020 [Dkt No. 1693] the Court approved a prior stipulation between the Parties to continue the Reply Deadline to August 31, 2020.
