1 **STIPULATION**

2 This stipulation (the “Stipulation”) is entered into between Astria Health
3 (“Astria”), a Washington nonprofit corporation, along with the above-referenced
4 affiliated debtors (collectively, the “Debtors”), the debtors and debtors in possession
5 in the above-captioned chapter 11 bankruptcy cases (collectively, the “Chapter 11
6 Cases”), and Doniel Drazin MD (“Drazin”, and together with the Debtors, the
7 “Parties”).

8 **RECITALS**

9 1. The Debtors filed voluntary petitions for relief under chapter 11 of title
10 11 of the United States Code, 11 U.S.C. §§ 101, *et seq.* (“Bankruptcy Code”) on May
11 6, 2019 (the “Petition Date”).

12 2. On July 7, 2020, the Debtors filed the Joint Chapter 11 Plan of
13 Reorganization of Astria Health and Its Debtor Affiliates (the “Plan”) [Docket No.
14 1471], which was amended on November 4, 2020 and November 11, 2020 [Docket
15 Nos. 1967, 1986] and the Disclosure Statement Relating to the Joint Chapter 11 Plan
16 of Reorganization of Astria Health and Its Debtor Affiliates (the “Disclosure
17 Statement”) [Docket No. 1472] describing the Plan, which was amended on
18 November 4, 2020 and November 11, 2020 [Docket Nos. 1968, 1987]. The Plan
19 proponents are the Debtors and Lapis (collectively, the “Plan Proponents”).

5. The Parties have now agreed to extend the deadline Voting Deadline and Confirmation Objection Deadline for Drazin until December 8, 2020, at 4:00 p.m.
