ORDER APPROVING: (I) THE DISCLOSURE STATEMENT; (II) PROCEDURES FOR THE SOLICITATION AND TABULATION OF VOTES TO ACCEPT OR REJECT THE PLAN; AND (III) RELATED NOTICE AND OBJECTION PROCEDURES

This matter is before the Court on the *Motion for Entry of an Order Approving (I) the Disclosure Statement; (II) Procedures for the Solicitation and Tabulation of Votes to Accept or Reject the Debtors’ Chapter 11 Plan; and (III) Related Notice and Objection Procedures* [Docket No. 730] (the “Motion”) of Cagle’s, Inc. (“Cagle’s”) and Cagle’s Farms, Inc. (collectively, the “Debtors”). All capitalized terms used but not defined herein shall have the meanings ascribed to them in the Motion.



The Court has considered the Motion, the *Amended and Restated Disclosure Statement for Amended and Restated Plan of Liquidation for Cagle's, Inc. and Cagle's Farms, Inc.*, dated September 6, 2012 [Docket No. 846] (the "Disclosure Statement"), the papers in support thereof and the responses thereto (if any), and the matters reflected in the record of the hearing held on the Motion on September 6, 2012 (the "Hearing"). It appears that the Court has jurisdiction over this proceeding; that this is a core proceeding; that the Debtors have filed with the Court the Disclosure Statement and the *Amended and Restated Plan of Liquidation for Cagle's, Inc. and Cagle's Farms, Inc.*, dated September 6, 2012 [Docket No. 847] (the "Plan"); that notice of the Motion has been given to the parties on the Master Service List established in these cases; the notice of the Hearing was properly served on the Debtors' creditors and equity security holders; that no further notice is necessary; that the notice of the Hearing provided that any responses to the Motion must be received by the Clerk no later than 5:00 p.m. (Eastern Standard Time) on August 29, 2012 (the "Objection Deadline"); that no responses or objections to the Motion were received by the Clerk as of the Objection Deadline; that the relief sought in the Motion is in the best interests of the Debtors, their estates, and their stakeholders; and that good and sufficient cause exists for such relief.

IT IS HEREBY FOUND THAT:

A. The Disclosure Statement filed in these chapter 11 cases (as the same may have been amended and/or revised from time to time, including in connection with the Hearing) contains "adequate information" within the meaning of section 1125 of the Bankruptcy Code.

B. The form of Notice of Non-Voting Status to be sent to Holders of Claims in Classes 1 and 2, substantially in the form attached hereto as Exhibit 1, complies with Bankruptcy Rule 3017, and adequately addresses the particular needs of these chapter 11 cases.

C. The forms of the Ballots attached hereto as Exhibit 2 are substantially consistent with Official Form No. 14, adequately address the particular needs of these chapter 11 cases, and are appropriate for each Class of Claims or Interests entitled to vote to accept or reject the Plan.

D. The Ballots require the furnishing of sufficient information to assure that duplicate Ballots are not submitted and tabulated and that Ballots reflect the votes of creditors and equity interest holders.

E. The period set forth below during which the Debtors may solicit acceptances to the Plan is a reasonable and adequate period of time for creditors and equity interest holders to make an informed decision to accept or reject the Plan.

F. The procedures for the solicitation and tabulation of votes to accept or reject the Plan (as more fully set forth in the Motion and below) provide for a fair and equitable voting process and are consistent with section 1126 of the Bankruptcy Code.

G. The Confirmation Hearing Notice substantially in the form attached hereto as Exhibit 3, the procedures set forth below for providing notice to all creditors and equity interest holders of the time, date and place of the Confirmation Hearing, and the contents of the Solicitation Packages comply with Bankruptcy Rules 2002 and 3017 and constitute sufficient notice to all interested parties.

NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

1. The Motion is GRANTED.
2. The Disclosure Statement is approved.
3. September 6, 2012 is established as the Voting Record Date for purposes of determining: (a) the Holders of Claims and the Holders of Interests entitled to vote to accept or

reject the Plan; and (b) in the case of nonvoting classes, the Holders of Claims and the Holders of Interests that are entitled to receive non-voting materials.

4. The form of Notice of Non-Voting Status, substantially in the form attached hereto as Exhibit 1, is approved and shall be distributed to Holders, as of the Voting Record Date, of Claims in Classes 1 and 2.

5. The Debtors are directed to distribute or cause to be distributed Solicitation Packages to all Holders of Claims and Holders of Interests in the Voting Classes, as follows:

- (a) all Persons identified in the Debtors' Schedules as holding liquidated, noncontingent and undisputed Unsecured Claims in an amount greater than zero dollars, excluding (i) scheduled Claims that have been paid in full, assumed by JCG Foods LLC, or superseded by filed proofs of claim prior to the Solicitation Date, and (ii) scheduled Claims validly transferred prior to the Voting Record Date;
- (b) all parties having timely filed proofs of claim, as reflected in the official claims register maintained by the Voting Agent, (i) in an amount greater than zero dollars, (ii) that have not been disallowed, expunged, or paid in full prior to the Solicitation Date, (iii) that have not been transferred and assigned prior to the Voting Record Date, and (iv) that, as of the Solicitation Date, are not subject to a pending objection of the Debtors seeking to disallow or expunge such Claim;
- (c) the assignee of a transferred and assigned Claim (whether a filed or scheduled Claim) whose transfer and assignment has been properly noted on the Court's docket and is effective pursuant to Bankruptcy Rule 3001(e) as of the close of business on the Voting Record Date and whose Claims have not been disallowed, expunged, or satisfied in full prior to the Solicitation Date and are not, as of the Solicitation Date, subject to a pending objection of the Debtors seeking to disallow or expunge such Claim;
- (d) all Holders of Interests in Cagle's, Inc. as reflected in the stock transfer ledger or similar register as of the Voting Record Date; and
- (e) any other known Holders of such Claims and Interests in the Voting Classes as of the Voting Record Date.

6. The Solicitation Packages shall contain copies of: (a) a cover letter describing the contents of the Solicitation Package; (b) this Order (without exhibits); (c) the Confirmation

Hearing Notice (as defined below); (d) an appropriate form of Ballot together with a pre-addressed, postage prepaid return envelope addressed to Cagle's Ballot Processing Center, c/o Kurtzman Carson Consultants, LLC, 2335 Alaska Avenue, El Segundo, California 90245; (e) the Disclosure Statement (together with the Plan annexed thereto and all other appendices); and (f) the letter in support of the Plan from J. Douglas Cagle substantially in the form of Exhibit E attached to the Debtors' *Notice of Filing of: (A) Amended and Restated Plan of Liquidation; (B) Amended and Restated Disclosure Statement; and (C) Proposed Letter to Stakeholders* [Docket No. 838] (the "Cagle Letter"). Solicitation Packages sent to Holders of Claims in Class 3 and Holders of Claims in Class 4 shall also include a copy of the letter of the Official Committee of Unsecured Creditors in support of the Plan (the "Committee Letter").

7. If, as of the Solicitation Date, a proof of claim is subject to a pending objection of the Debtors seeking to reclassify such Claim, the Debtors shall provide the Holder of the Claim a Ballot for the Class that the Holder would be entitled to vote in if the pending objection is sustained. If the Debtors' request for reclassification is denied subsequent to the Solicitation Date, the Debtors shall provide the Holder of the Claim with either a Ballot corresponding to the appropriate Class or, if applicable, the Notice of Non-Voting Status.

8. If a Claim that would otherwise be entitled to vote in Class 3 or Class 4 is, as of the Solicitation Date, subject to a pending objection of the Debtors seeking to disallow and expunge the Claim and the Debtors' objection is subsequently denied with respect to the Claim, the Debtors shall provide the Holder of the Claim with a Solicitation Package (including the appropriate Ballot).

9. The Debtors may send the Solicitation Packages in a CD-ROM format instead of printed hard copies; provided, however: (a) the Solicitation Packages shall include printed hard

copies of the cover letter, the Committee Letter (included only in Solicitation Packages sent to Holders of Claims in Class 3 and Holders of Claims in Class 4), the Cagle Letter and the applicable Ballot (along with an addressed, postage prepaid return envelope), and (b) the Debtors shall provide printed hard copies of all other documents in the Solicitation Package upon request.

10. The forms of the Ballots attached hereto as Exhibit 2 (including Exhibits 2A, 2B, 2C-I, 2C-II, and 2C-III) are approved.

11. To each Holder of an Interest in Class 5 that holds the underlying securities for its own benefit, the Debtors (or the Voting Nominee) shall send a Beneficial Holder Ballot substantially in the form attached hereto as Exhibit 2C-I.

12. To each Holder of an Interest in Class 5 that holds the underlying securities in direct registration on the books of the transfer agent, the Debtors shall send a Registered Holder Ballot substantially in the form of Exhibit 2C-II.

13. If a Holder of an Interest in Class 5 is a Voting Nominee, the Debtors shall provide such Voting Nominee with sufficient Solicitation Packages for distribution to each of the beneficial holders represented by the Voting Nominee.

14. Each Voting Nominee may elect to either: (a) “prevalidate” the Beneficial Holder Ballot contained in the Solicitation Package, forward the Solicitation Package to the beneficial holder, and instruct the beneficial holder to return the ballot to the Voting Agent; or (b) forward the Solicitation Package to the beneficial holder with instructions for the beneficial holder to return the Beneficial Holder Ballot to the Voting Nominee. To be prevalidated, a Ballot must indicate the name and address of the beneficial holder, the amount of the underlying securities, and the corresponding account numbers. In either instance, the Voting Nominee shall provide

the beneficial holder with the appropriate materials within five (5) business days of the Voting Nominee's receipt of the Solicitation Packages.

15. If the Voting Nominee elects option (b) in the preceding paragraph, the Voting Nominee shall tabulate the ballots on a Master Ballot substantially in the form of Exhibit 2C-III and return the Master Ballot to the Voting Agent by the Voting Deadline (as defined below).

16. The Debtors shall reimburse each Voting Nominee for its reasonable and customary costs and expenses associated with the distribution of the Solicitation Packages and tabulation of the Beneficial Holder Ballots.

17. Classes 1 and 2 are unimpaired and, therefore, conclusively presumed to accept the Plan in accordance with section 1126(f). Therefore, the Debtors shall not send any Ballots to Holders of Claims in these Classes.

18. Except as otherwise provided herein, to be counted as a vote to accept or reject the Plan, a Ballot must be properly executed, completed, and delivered to the Voting Agent: (i) by mail in the return envelope provided with the Ballot, (ii) by overnight courier, or (iii) by personal delivery so that, in each case, the Ballot is received by the Voting Agent no later than 4:00 p.m., Pacific time, on October 11, 2012 (the "Voting Deadline"). No Ballots may be submitted by facsimile or electronic mail, and any Ballots submitted by facsimile or electronic mail will not be accepted or counted.

19. The Debtors may extend the Voting Deadline, if necessary or desirable in the sole discretion of the Debtors, without further order of the Court, to a date that is no later than three days before the Confirmation Hearing by publishing on <http://www.kccllc.net/Cagles> an announcement of such extension.

20. Solely for purposes of voting to accept or reject the Plan, not for the purposes of the allowance of or distribution on account of a Claim, and without prejudice to the rights of the Debtors in any other context, each Holder of a Claim within a Class of Claims entitled to vote to accept or reject the Plan shall be entitled to vote the amount of such Claim as set forth in the Schedules (as may be amended from time to time) unless (a) such Holder has timely filed a proof of claim, in which event such Holder would be entitled to vote the amount of such Claim as set forth in such proof of claim; or (b) the Debtors have satisfied such Claim in accordance with orders of the Court or such Claim has been assumed by JCG Foods LLC, in which event such Holder would be entitled to vote only the amount (if any) of such Claim that had not been satisfied or assumed. The foregoing general procedure will be subject to the following exceptions:

- a. if a Claim is deemed "Allowed" under the Plan or an order of the Court, such Claim is Allowed for voting purposes in the deemed "Allowed" amount set forth in the Plan or the Court's order;
- b. if a Claim for which a proof of claim has been timely filed is wholly contingent, unliquidated or disputed (as determined by the Debtors after a reasonable review of the Claim and its supporting documentation), such Claim shall be temporarily Allowed for voting purposes only, and not for purposes of allowance or distribution, at \$1.00, and the Ballot mailed to the Holder of such Claim shall be marked as voting at \$1.00;
- c. if a Claim is partially liquidated and partially unliquidated, such Claim shall be Allowed for voting purposes only in the liquidated amount;
- d. if a Claim has been estimated or otherwise Allowed for voting purposes by order of the Court, such Claim is temporarily Allowed in the amount so estimated or Allowed by the Court for voting purposes only, and not for purposes of allowance or distribution;
- e. if a Claim is listed in the Schedules as contingent, unliquidated or disputed and a proof of claim was not (a) filed by the applicable bar date for the filing of proofs of claim established by the Court or (b) deemed timely filed by an order of the Court prior to the Voting Deadline, then, unless the Debtors have consented in writing, such Claim shall be disallowed for voting purposes;

- f. if the Debtors have filed an objection to a Claim before the Voting Deadline seeking to disallow and expunge a Claim and such objection either has been sustained or is pending as of the Voting Deadline, such Claim shall be disallowed for voting purposes only and not for purposes of allowance or distribution, except to the extent and in the manner as may be set forth in any order sustaining the objection;
- g. if the Debtors have filed an objection to a Claim before the Voting Deadline seeking to reduce the Claim and such objection either has been sustained or is pending as of the Voting Deadline, the amount of the Claim shall be reduced to the amount set forth in the objection for voting purposes only and not for purposes of allowance or distribution, except to the extent and in the manner as may be set forth in any order sustaining the objection;
- h. if the Debtors have filed an objection to a Claim before the Voting Deadline seeking to reclassify the Claim and such objection either has been sustained or is pending as of the Voting Deadline, the Holder of the Claim shall be classified as set forth in the objection for voting purposes only and not for purposes of allowance or distribution, except to the extent and in the manner as may be set forth in any order sustaining the objection; and
- i. notwithstanding anything to the contrary contained herein, any creditor who has filed or purchased duplicate Claims (whether against the same or multiple Debtors) that are classified under the Plan in the same Class, shall be provided with only one Solicitation Package and one Ballot for voting a single Claim in such Class, regardless of whether the Debtors have objected to such duplicate Claims.

21. Those Holders of Interests in Cagle's that are reflected in Cagle's stock transfer ledger or similar register as of the Voting Record Date will be the holders of record and, as such, will be entitled to vote to accept or reject the Plan.

22. With respect to the tabulation of Master Ballots, Beneficial Holder Ballots, and Registered Holder Ballots, for purposes of voting, the Voting Agent shall use the amount of shares held as of the Voting Record Date (the "Record Amount").

23. The following additional rules will apply to the tabulation of Master Ballots, Beneficial Holder Ballots, and Registered Holder Ballots:

- a. Votes cast by beneficial holders through a Voting Nominee will be applied against the positions held by such Persons in the securities as of Voting

Record Date as evidenced by the record and depository listings. Votes submitted by a Voting Nominee, whether pursuant to a Master Ballot or prevalidated Ballots, will not be counted in excess of the Record Amount of such securities held by such Voting Nominee.

- b. To the extent that conflicting votes or “overvotes” are submitted by a Voting Nominee, whether pursuant to a Master Ballot or prevalidated Ballots, the Voting Agent will attempt and is authorized to reconcile discrepancies with the Voting Nominees.
- c. To the extent that overvotes on a Master Ballot or prevalidated Ballots are not reconcilable prior to the vote certification, the Voting Agent will apply the votes to accept and to reject the Plan submitted on the Master Ballot or prevalidated Ballots that contained the overvote, but only to the extent of the Voting Nominee’s position in the security.

24. If any creditor seeks to challenge the allowance of its Claim for voting purposes in accordance with the above procedures, such claimant is directed to serve on counsel for Debtors and file with the Court a Rule 3018 Motion no later than the later of: (a) September 27, 2012; and (b) 5:00 p.m. (Eastern time) on the seventh day after the date of service of an objection, if any, to such Claim.

25. As to any creditor filing such a motion, such creditor’s Ballot shall not be counted unless temporarily allowed by the Court for voting purposes after notice and a hearing. If and to the extent that the Debtors and such party are unable to resolve the issues raised by the Rule 3018 Motion prior to the Voting Deadline established by the Court, then at the Confirmation Hearing the Court will determine whether the provisional Ballot should be counted as a vote on the Plan.

26. If a Holder of a Claim or a Holder of an Interest entitled to vote to accept or reject the Plan casts more than one Ballot voting the same Claim or Interest before the Voting Deadline, the last properly completed Ballot received before the Voting Deadline shall be deemed to reflect the voter’s intent and, thus, to supersede any prior Ballots.

27. Creditors with multiple Claims within a particular Class must vote all of their Claims within such Class either to accept or reject the Plan and may not split their votes, and thus neither (i) any Ballot that partially rejects and partially accepts the Plan nor (ii) any Ballot filed by a creditor with multiple Claims within a Class that votes inconsistently, will be counted.

28. Any Ballot that is properly completed, executed, and timely returned to the Voting Agent but does not indicate an acceptance or rejection of the Plan or indicates both an acceptance and a rejection of the Plan shall be counted as an acceptance of the Plan.

29. Any Ballot actually received by the Voting Agent after the Voting Deadline shall not be counted unless the Debtors granted an extension of the Voting Deadline with respect to such Ballot.

30. Any Ballot that is illegible or contains insufficient information to permit the identification of the Person that submitted the Ballot shall not be counted.

31. Any Ballot cast by a Person that does not hold a Claim or Interest in a Class that is entitled to vote to accept or reject the Plan shall not be counted.

32. Any Ballot cast for a Claim scheduled as unliquidated, contingent, or disputed and for which no proof of claim was timely filed shall not be counted.

33. Any unsigned Ballot or non-originally signed Ballot shall not be counted unless expressly authorized by the Debtors (in their sole discretion).

34. Any Ballot sent directly to any of the Debtors, their agents (other than the Voting Agent), the Debtors' financial or legal advisors, or any party other than the Voting Agent shall not be counted.

35. Any Ballot cast for a Claim that has been disallowed (for voting purposes or otherwise) shall not be counted.

36. Any Ballot transmitted to the Voting Agent by facsimile or other electronic means shall not be counted unless expressly authorized by the Debtors (in their sole discretion).

37. The Debtors may reject any and all Ballots the acceptance of which, in the opinion of the Debtors, would not be in accordance with the provisions of the Bankruptcy Code or the Bankruptcy Rules. The Debtors may also waive (in their sole discretion) any defects or irregularities as to any particular Ballot at any time, either before or after the Voting Deadline; provided, however, that any such waivers shall be documented in the tabulation report filed by the Voting Agent with the Court.

38. No Person (including the Debtors and the Voting Agent) shall be under any duty to provide notification of defects or irregularities with respect to delivered Ballots, nor shall the Debtors, the Voting Agent or any other Person incur any liability for failure to provide such notification.

39. The Voting Agent may disregard any and all defective ballots with no further notice to any other Person.

40. The Voting Agent will file a certificate of tabulation on or before October 15, 2012.

41. The Confirmation Hearing will be held at 2:00 p.m. (prevailing Eastern time) on October 18, 2012; *provided, however*, that the Confirmation Hearing may be adjourned from time to time by the Court or the Debtors without further notice to parties other than an announcement in Court at the Confirmation Hearing or any adjourned Confirmation Hearing.

42. The Confirmation Hearing Notice substantially in the form attached hereto as Exhibit 3 is approved and shall be transmitted to all creditors and equity interest holders of the Debtors.

43. The Debtors shall publish the Confirmation Hearing Notice electronically on <http://www.kccllc.net/Cagles>.

44. The Debtors shall send Solicitation Packages, Notices of Non-Voting Status, and Confirmation Hearing Notices as required by this Order only to known deliverable addresses; provided, however, the Debtors shall send Solicitation Packages, Notices of Non-Voting Status, and Confirmation Hearing Notices as required by this Order to any Person that provides written notice of a new mailing address or forwarding address prior to the Solicitation Date. The failure to distribute Solicitation Packages, Notices of Non-Voting Status, or Confirmation Hearing Notices to Persons at undeliverable addresses will not constitute a violation of Bankruptcy Rule 3017(d) or inadequate notice of the Confirmation Hearing, the Voting Deadline, or this Order.

45. Objections to confirmation of the Plan or proposed modifications to the Plan, if any, must: (a) be in writing; (b) conform to the Bankruptcy Rules and the Local Rules; (c) state the name and address of the objecting party and the amount and nature of the Claim or Interest of such party; (d) state with particularity the basis and nature of any objection to the Plan; and (e) be filed, together with proof of service, with the Court electronically and served on the parties listed in the Confirmation Hearing Notice, on or before 5:00 p.m. (prevailing Eastern time) on October 11, 2012.

46. Objections to confirmation of the Plan not timely filed and served in the manner set forth above may not be considered and may be overruled.

47. The Debtors are authorized to take or refrain from taking any action and expending such funds necessary or appropriate to implement the terms of and the relief granted in this Order without seeking further order of the Court.

48. The Debtors are authorized to make nonsubstantive changes to the Disclosure Statement, Plan, Ballots, the Confirmation Hearing Notice, any other notice related to the Plan or Disclosure Statement and all exhibits and appendices to any of the foregoing without further order of the Court, including, without limitation, changes to correct typographical and grammatical errors and to make conforming changes among the Disclosure Statement, the Plan and any other materials in the Solicitation Package prior to their distribution.

NOTICE OF NON-VOTING STATUS UNDER THE DEBTORS’ AMENDED AND RESTATED CHAPTER 11 PLAN DATED AS OF SEPTEMBER 6, 2012

1. On October 19, 2011 (the “Petition Date”), the above-captioned debtors and debtors in possession (collectively, the “Debtors”) filed voluntary petitions for relief under chapter 11 of title 11 of the United States Code (the “Bankruptcy Code”).

2. On September __, 2012, the United States Bankruptcy Court for the Northern District of Georgia, Atlanta Division (the “Bankruptcy Court”) entered an Order Approving (I) the Disclosure Statement; (II) Procedures for the Solicitation and Tabulation of Votes to Accept or Reject the Plan; and (III) Related Notice and Objection Procedures [Docket No. __] (the “Approval Order”).

3. Among other things, the Approval Order: (a) approved the *Amended and Restated Disclosure Statement for Amended and Restated Plan of Liquidation Filed by Cagle’s, Inc. and Cagle’s Farms, Inc., dated September 6, 2012* [Docket No. 846] (the “Disclosure Statement”); (b) established certain procedures (collectively, the “Solicitation Procedures”) for the solicitation and tabulation of votes to accept or reject the *Amended and Restated Plan of Liquidation for Cagle’s, Inc. and Cagle’s Farms, Inc., dated September 6, 2012* [Docket No. 847] (as may be amended, the “Plan”); (c) approved the contents of the proposed solicitation packages to be distributed to the Debtors’ stakeholders who are entitled to vote to accept or reject the Plan (collectively, the “Solicitation Packages”); (d) approved the form of notice to be sent to certain stakeholders who are not entitled to vote to accept or reject the Plan; and (e) approved other notice and objection procedures in connection with the hearing to confirm the Plan (the “Confirmation Hearing”). All capitalized terms used but not defined herein shall have the meanings ascribed to them in the Plan.

4. 1. Pursuant to an order dated September __, 2012 [Docket No. ___] (the “Approval Order”), the United States Bankruptcy Court for the Northern District of Georgia, Atlanta Division (the “Court”) has (a) approved the *Amended and Restated Disclosure Statement for Amended and Restated Plan of Liquidation Filed by Cagle’s, Inc. and Cagle’s Farms, Inc., dated September 6, 2012* [Docket No. 846] (the “Disclosure Statement”) filed by the above-captioned debtors and debtors in possession (the “Debtors”) and (b) authorized the Debtors to solicit votes to accept or reject the *Amended and Restated Plan of Liquidation for Cagle’s, Inc. and Cagle’s Farms, Inc., dated September 6, 2012* [Docket No. 847] (as may be amended, the “Plan”). All capitalized terms used but not defined herein shall have the meanings ascribed to them in the Plan.

2. The Approval Order establishes September 6, 2012 as the Record Date for determining the holders of prepetition Claims and holders of Interests entitled to vote to accept or reject the Plan and establishes **4:00 p.m. on October 11, 2012** as the Voting Deadline for submission of ballots to accept or reject the Plan (the “Ballots”). Holders of Claims and Holders of Interests entitled to vote to accept or reject the Plan will receive the following materials: (a) this Notice, (b) a copy of the Approval Order (without exhibits) to which this Notice corresponds, (c) the Disclosure Statement, (d) the Plan, (e) one or more Ballots (and return envelopes) to be used in voting to accept or reject the Plan, and (f) the letter of J. Douglas Cagle in support of the Plan (collectively, the “Solicitation Package”). Solicitation Packages sent to Holders of Claims in Class 3 and Holders of Claims in Class 4 shall also include the letter of the Official Committee of Unsecured Creditors in support of the Plan.
