**NOTICE OF CLAIMS TO BE EXPUNGED

PLEASE TAKE NOTICE of the following information, as it may affect your rights with respect to the Debtor (defined below):

PLEASE TAKE NOTICE that, on January 13, 2021, the Court entered its *Findings of Fact, Conclusions of Law and Order Confirming Chapter 11 Trustee’s Second Amended Plan of Liquidation for Debtor CFO Management Holdings, LLC (with Technical Modifications and Certain Settlement Language)* [Docket No. 663] (the “**Confirmation Order**”), confirming the plan of liquidation proposed by David Wallace in his capacity as Chapter 11 trustee (the “**Trustee**”) for debtor CFO Management Holdings, LLC.

PLEASE TAKE FURTHER NOTICE that the Confirmation Order and supporting papers, including the *Chapter 11 Trustee’s Second Amended Plan of Liquidation for Debtor CFO Management Holdings, LLC (with Technical Modifications and Certain Settlement Language)* [Docket No. 659] (the “**Plan**”) are available at no cost on the website for this bankruptcy case: <http://www.kccllc.net/cfomanagementholdings>. PLEASE TAKE FURTHER NOTICE that in accordance with Article 7.3.1 of the Plan,

Any Claim that has been paid, satisfied, amended, duplicated, or superseded, may be adjusted or expunged on the Claims Register by the Liquidation Trustee on or after 14 calendar days after the date on which the Trustee or Liquidation Trustee files notice of such adjustment or expungement with the Bankruptcy Court, provided that no objection is filed or otherwise remains unresolved in that 14-day period. Such

In these exhibits, the Trustee has indicated those claims that he is instructing KCC to remove as expunged in accordance with Article 7.3.1. of the Plan following the 14-day period described above.

If you do not disagree with the designations provided in the attached exhibits, you do not need to take any action in response to this notice, and the identified claims will be removed from the Claims Registry. **The claims identified as “remaining” will not be affected by the removal process triggered by this notice.** This process seeks only to remove paid, satisfied, amended, duplicate, or superseded claims, NOT the subsequently filed claims that took their place or valid claims that remain otherwise unsatisfied.

Should there be a dispute between the Trustee and a creditor regarding the removal of that creditor’s claim(s), such disputed claim(s) will remain in the Claims Registry but be designated as “disputed” and not “Allowed” until further determination of the Bankruptcy Court or resolution under the terms of the Plan.
