**FIFTH STIPULATION REGARDING EXTENSION OF TIME TO RESPOND  
TO TRUSTEE’S OBJECTION TO CLAIM NO. 369 FILED BY BMC WEST, LLC**

David Wallace, Chapter 11 Trustee for the Bankruptcy Estate of CFO Management Holdings, LLC, and, following the effective date of the confirmed plan of liquidation in this bankruptcy case, the Liquidating Trustee of the CFO Management Holdings Liquidation Trust (“Trustee”) and BMC West, LLC (“BMC”) file this *Fifth Stipulation Regarding Extension of Time to Respond to Trustee’s Objection to Claim No. 369 filed by BMC West, LLC* and respectfully state as follows: The Trustee and BMC previously agreed and stipulated to an extended response deadline of (to and including) September 13, 2021. The Trustee and BMC have now agreed and stipulated to a further extended response deadline of (to and including) **September 27, 2021**, to permit time to finalize certain settlement details with general contractor EMJ Construction, which
