**STIPULATION FOR ENTRY OF ORDER
EXTENDING TIME FOR ANSWER TO COUNTER-CLAIM**

Plaintiff/Counter-Defendant the Police and Fire Retirement System of the
City of Detroit and Defendant/Counter-Plaintiff Investment Committee of the
Police and Fire Retirement System of the City of Detroit stipulate as follows:



1. The parties participated in an all-day mediation with mediator Howard Sher on April 29, 2020. Although final resolution of the case was not reached, the parties have continued negotiations since then, and have exchanged drafts of a settlement agreement and emails regarding settlement. The parties continue to discuss settlement. They have kept the mediator informed, and have requested that he delay his report to the Court in hopes that a resolution can be reached.

2. Plaintiff/Counter-Defendant the Police and Fire Retirement System of the City of Detroit's answer to the counter-claim filed by the Defendant/Counter-Plaintiff Investment Committee of the Police and Fire Retirement System of the City of Detroit is due on May 15, 2020.

3. The parties have agreed to extend the date that an answer is due in response to the counter-claim until June 15, 2020.
