STATUS REPORT

Province, Inc., as Wind Down Administrator of the Orexigen Wind Down Entity in the above-captioned proceeding (the “Proceeding”), hereby files this status report at the request of the Court.

BACKGROUND

1. On March 12, 2018 (the “Petition Date”), the Debtors filed voluntary petitions for relief under title 11 of the United States Code, 11 U.S.C. § 101 through 1532 (the “Bankruptcy Code”) in this Court commencing the Chapter 11 Cases.
2. On July 31, 2018, the Court entered the *Order Authorizing the Appointment of Thomas P. Lynch as the Debtor’s Wind Down Officer* [Docket No. 663].
3. On May 17, 2019, the Court entered the *Findings of Fact, Conclusion of Law, and Order Confirming Debtor’s Modified Amended Plan of Liquidation* [Docket No. 1113] (the “Confirmation Order”), confirming the *Debtor’s Modified Amended Plan of Liquidation* (the “Plan”), providing for the creation of the Wind Down Entity to administer the Wind Down Assets (as defined in the Plan).
4. The Plan became effective on May 31, 2019 (the “Effective Date”). See Docket Nos. 1125 and 1127 (the “Effective Date Notice”).

5. Since entry of the Effective Date, the Wind Down Administrator reconciled all Claims, including Administrative Claims, asserted against the Debtors' estates, either through claim objections, formal or informal stipulations and agreements. *See, e.g.*, Docket Nos. 592, 1179, 1195, 1229, and 1230.

6. The Wind Down Administrator has also resolved all outstanding litigation involving the Debtors.

7. Accordingly, the Wind Down Administrator is prepared to make final distributions and otherwise close the Chapter 11 Case and will be filing a motion for a final decree shortly.
