**NOTICE OF PROTERRA POWERED SALE CLOSING**

**PLEASE TAKE NOTICE THAT**, on November 10, 2023, the Debtors filed the *Notice of Successful Bidder Regarding Debtors' Powered Assets* [Docket No. 525] (the "Notice of Successful Bidder"), thereby announcing that Volvo Battery Solutions LLC ("Volvo") was the Successful Bidder at the conclusion of the Auction<sup>2</sup> for the Powered Assets.

**PLEASE TAKE FURTHER NOTICE THAT**, attached to the Notice of Successful Bidder at Exhibit A was that certain *Asset Purchase Agreement* (as it may be amended in accordance with its terms, the "APA") by and among the Debtors and Volvo for the Powered Assets.

**PLEASE TAKE FURTHER NOTICE** that, on November 29, 2023, the United States Bankruptcy Court for the District of Delaware entered the *Order (A) Authorizing and Approving the Debtors' Entry Into the Asset Purchase Agreement, (B) Authorizing the Sale of the Debtors' Powered Assets Free and Clear of All Liens, Claims, Interests, and Encumbrances, (C) Approving the Assumption and Assignment of the Assumed Executory Contracts and Unexpired Leases, and (D) Granting Related Relief* [Docket No. 664] (the "Sale Order"), thereby approving the sale of the Powered Assets to Volvo pursuant to the APA, a copy of which is attached to the Sale Order as Exhibit A.

**PLEASE TAKE FURTHER NOTICE** that, on December 4, 2023, the Debtors filed the *Notice of Filing First Amendment to Asset Purchase Agreement By and Among the Debtors and Volvo Battery Solutions LLC* [Docket No. 625].

**PLEASE TAKE FURTHER NOTICE** that, on February 1, 2024, the sale of the Powered Assets closed in accordance with the APA (the "Closing").
