1 Plaintiff THE ROMAN CATHOLIC BISHOP OF OAKLAND, plaintiff in the above-captioned
2 action, for its First Amended Complaint for Declaratory Judgment Relief, Breach of Contract, and
3 Breach of Statutory Duty (the “First Amended Complaint”) against Defendants AMERICAN HOME
4 ASSURANCE CO., a New York corporation; LEXINGTON INSURANCE CO., a Delaware
5 corporation (collectively, the “Defendants”), alleges as follows:

6 Attached hereto is Exhibit A which lays out the specific claims. Each claim details the claim
7 number designated by RCBO, the case number assigned to the case by the court below, the name of the
8 insurance carrier, the years of the alleged abuse, the date RCBO tendered the claim to its respective
9 insurers, the date of the insurer’s response, and the insurer’s response.

10 **JURISDICTION AND VENUE**

11 1. This Court has jurisdiction over this adversary proceeding pursuant to sections 157 and
12 1334 of title 28 of the United States Code (“Title 28”).

13 2. This proceeding is a core proceeding pursuant to sections 157(b) of Title 28.

14 3. Venue in this Court is proper pursuant to sections 1408 and 1409 of Title 28.

15 4. Plaintiff consents to the entry of a final order or judgment by this Court in connection
16 with this adversary proceeding to the extent it is later determined that this Court, absent consent of the
17 parties, cannot enter final orders or judgments consistent with Article III of the United States
18 Constitution.

19 **NATURE OF THE ACTION**

20 5. This is an action for breach of contract and declaratory judgment.

21 **THE PARTIES**

22 6. Plaintiff THE ROMAN CATHOLIC BISHOP OF OAKLAND (“RCBO” or the
23 “Debtor”) is a California corporation sole with its principal place of business in Oakland, California.

24 7. Defendant AMERICAN HOME ASSURANCE CO. (“AMERICAN HOME”) is, on
25 information and belief, a New York corporation which conducted business in this District and issued
26 written excess policies of insurance to RCBO under Policy No. CE 35-60-94 for the period October 26,
27 1971 to October 26, 1974 (herein “AHAC”). Specifically, AHAC is responsive to certain claims,
28 including but not limited to the following claims: 12, 68, 87a, 126, 171, 330, 352;

8. Defendant LEXINGTON INSURANCE CO. is, on information and belief, a Delaware corporation which conducted business in this District and issued written excess policies of insurance to RCBO under Policy No. 6502093 for the period October 5, 2007 to July 1, 2008 (herein “LEXINGTON”). Specifically, LEXINGTON is responsive to certain claims, including but not limited to the following claims: 12, 67, 87a, 126, 171, 330, 352.

FACTUAL BACKGROUND

9. On August 30, 2023, the Debtor filed the Complaint for declaratory relief and breach of contract, seeking to liquidate the Debtor’s claims against numerous of its historical insurance carriers. [Docket No. 1 with attached Exhibit and Attachment (collectively, the “Complaint”)]. RCBO incorporates herein its Complaint.

10. Debtor files this First Amended Complaint to address the issues raised in the motions to dismiss and the Court's order in Debtor's companion case, No: 23-40523 WJL.

11. RCBO has been named in more than 400 complaints primarily filed in the Alameda Superior Court as well as proofs of claim filed in this Court seeking recovery for alleged negligent supervision and hiring of certain clerical and ministerial personnel over a period of decades. These suits and proofs of claim (collectively referred to as the “Suits”) have been filed as a result of California’s passing of AB 218, which extended the statute of limitations for the filing of similar civil suits.

12. Although section 362 of the Bankruptcy Code provides for an automatic stay of the Suits and of additional lawsuits against the Debtor, RCBO is informed, and believes, that additional suits may be filed and/or served after the filing of this proceeding and RCBO will update the list to reflect all such cases as appropriate.

13. Although section 362 of the Bankruptcy Code provides for an automatic stay of the Suits and of additional lawsuits against the Debtor, RCBO is informed, and believes, that additional suits may be filed and/or served after the filing of this proceeding and RCBO will update the list to reflect all such cases as appropriate.

14. RCBO has maintained insurance coverage through a series of primary, excess and umbrella insurers from the early 1960's through the present time as alleged above.

15. RCBO has tendered through its broker (i.e., “AJG” as designated in Exhibit A) both

1 RCBO's defense and indemnity of the Suits under all applicable insurance policies to the associated
2 Defendants that issued those policies and were not insolvent.

3 16. The Defendants as excess insurers received the tenders of the Suits on behalf of RCBO
4 but have improperly denied or failed to confirm coverage (including, without limitation, failure to
5 provide both defense and/or indemnity) for the Suits as reflected in Exhibit A – including failure to
6 recognize the exhaustion of underlying insurance through payment, liquidation or other means thereby
7 requiring the excess insurance to drop down and provide defense and indemnity to RCBO for the Suits.
8 RCBO contends that it is entitled to the payment of defense and/or indemnity amounts from the
9 Defendants on the grounds that RCBO timely tendered the Suits to the Defendants and has met all the
10 conditions of the respective policies of insurance. RCBO further asserts that the Suits seek recovery for
11 claims of “bodily injury” as that term is defined in the Defendants’ respective policies of insurance and
12 therefore the claims come within the coverage grant of the respective insurance policies. Further,
13 RCBO contends that the claims made in the Suits are not excluded by the respective insurance policies.
14 In addition, without limitation, RCBO contends that it did not intend nor know of any of the alleged
15 events in the Suits such that it would result in the negation of coverage under the applicable policies.
16 Finally, RCBO contends that it is presently facing in excess of 400 Suits seeking a total amount of
17 damages which has the substantial likelihood of being in excess of the available limits of insurance
18 available under the Defendants’ respective insurance policies. Therefore, the Defendants owe RCBO
19 both defense and indemnity for the Suits.

20 17. As a result of the conduct of the Defendants, RCBO has been harmed in that it has not
21 been provided with the benefits of the insurance it purchased, having complied with all requirements
22 thereunder. RCBO has been forced to defend itself against the Suits without being provided with the
23 appropriate required defense and indemnity that was to be provided by the Defendants through their
24 respective policies of insurance. Consequently, an actual and justiciable controversy exists between the
25 parties of sufficient immediacy and reality to warrant issuance of a declaratory judgment.

26 **FIRST CAUSE OF ACTION**

27 **(Declaratory Relief Against all Defendants)**

28 18. RCBO realleges and incorporates herein paragraphs 1 through 17 of this complaint as if

1 said paragraphs were set forth in full.

2 19. To state a claim for a declaratory judgment, a party needs to plead an actual controversy.
3 28 U.S.C. § 2201; Cal. Code. Civ. P. § 1060; *see also, e.g., Marks v. UMG Recordings, Inc.*, 2023 WL
4 4532774, at *3 n.2 (9th Cir. July 13, 2023) (acknowledging that “California law unambiguously
5 provides a claim for declaratory relief when there is an actual controversy about the parties’ rights and
6 duties under a contract”).

7 20. An actual and justiciable controversy has arisen and now exists between the parties with
8 respect to whether the Defendants, and each of them, are obligated to provide RCBO with defense and
9 indemnity under their respective insurance policies regarding the Suits.

10 21. Pursuant to the respective insurance policies, each of the Defendants is obligated to pay
11 in full the expenditures made by RCBO to defend itself against the Suits.

12 22. The insurance policies RCBO purchased from various insurance carriers provide
13 coverage for many if not all of the Suits asserted against RCBO and constitute the most significant
14 source of recovery for the alleged abuse victims in the Bankruptcy Case.

15 23. Pursuant to the terms of the respective insurance policies, each of the Defendants is
16 obligated to defend and indemnify RCBO for, or pay on its behalf, all sums that RCBO becomes
17 obligated to pay, through judgment, settlement, or otherwise, arising out of the Suits.

18 24. RCBO has fully performed under the Defendants’ respective insurance policies.

19 25. The Defendants have received tenders on behalf of RCBO regarding the Suits but have
20 improperly denied and/or have failed to confirm coverage for the Suits and have further failed to provide
21 RCBO with either defense and/or indemnity regarding the Suits as required under the respective
22 policies. *See* Exhibit A. To the extent that the Defendants have issued reservation of rights letters in
23 response to RCBO’s tenders (as reflected in Exhibit A), the Defendants have not actually provided the
24 benefits of their respective policies to RCBO – *i.e.*, actual defense and/or indemnity payments.

25 26. Each of the Defendant’s refusal to defend and/or indemnify RCBO constitutes a breach
26 of the insurance policies or, in the case of CIGA, a breach of its statutory duties.

27 27. In the meantime, the Suits are pending, resulting in loss and damages to RCBO including,
28 without limitation, defense fees and costs and indemnity funds (whether via judgment or settlement or

1 other means).

2 28. An actual controversy of a justiciable nature presently exists between RCBO and the
3 Defendants concerning the proper construction of the respective insurance policies, the scope of the
4 statutory obligations assumed by CIGA, and the rights and obligations of the parties with respect to the
5 Suits. The controversy is of sufficient immediacy and magnitude to justify the issuance of a declaratory
6 judgment.

7 29. RCBO is entitled to a judgment declaring that the Defendants have issued insurance
8 policies to RCBO and that RCBO is entitled to both defense and indemnity regarding the Suits under the
9 respective policies of insurance issued by the Defendants.

10 30. As a direct and proximate result of the Defendants' breaches, RCBO has been damaged
11 according to proof at trial.

12 **SECOND CAUSE OF ACTION**

13 **(Breach of Contract Against All Defendants)**

14 31. RCBO realleges and incorporates herein paragraphs 1 through 30 of this complaint as if
15 said paragraphs were set forth in full.

16 32. "An insured can pursue a breach of contract theory against its insurer by alleging [1] the
17 insurance contract, [2] the insured's performance or excuse for nonperformance, [3] the insurer's breach,
18 and [4] resulting damages." *San Diego Housing Comm'n v. Indus. Indem. Co.*, 68 Cal. App. 4th 526,
19 536 (1998).

20 33. The Defendants' policies are valid and enforceable contracts providing insurance
21 coverage for the damage incurred by RCBO.

22 34. The Defendants have received timely tenders of the Suits. *See* Exhibit A.

23 35. The Defendants' failure to provide defense and indemnity to RCBO for the Suits is
24 contrary to the coverages and benefits promised RCBO under the respective policies and constitutes a
25 breach of those policies.

26 36. RCBO has fully performed under the Defendants' respective insurance policies and the
27 Defendants, and each of them, are not excused from performance.

28 37. As a direct and proximate result of the Defendants' breaches, RCBO has been damaged

1 according to proof at trial.

2 38. As a result of the Defendants' breaches of their respective insurance policies, RCBO has
3 incurred significant fees and costs in defending itself in the Suits and has not been provided with the
4 required coverage for indemnity (including any settlement amounts), all to the injury and damage of
5 RCBO.

6 39. Furthermore, the Defendants' refusal to provide the promised coverage hampers the
7 Debtor's ability to propose and implement a confirmable plan of reorganization.

8
9 **PRAYER FOR RELIEF**

10 WHEREFORE, RCBO prays for relief as follows:

11 a. For a declaration in RCBO's favor as to the obligation of the Defendants, and
12 each of them, that the Defendants issued effective policies of insurance to RCBO and a further
13 declaration that the Defendants were obligated to provide defense and indemnity to RCBO
14 regarding the claims made in the Suits;

15 b. For an award in RCBO's favor as a result of the Defendants' breach of their
16 respective policies;

17 c. For an order awarding RCBO its costs, expenses, and reasonable attorneys' fees
18 as provided by law; and

19 d. For such other and further relief as the Court deems just and proper.
