**NOTICE OF CORRECTED LIST OF
DESIGNATED STORE CLOSING LOCATIONS**

PLEASE TAKE NOTICE that, on March 2, 2016, Sports Authority Holdings, Inc. and its affiliated debtors and debtors in possession in the above-captioned chapter 11 cases (collectively, the “Debtors”), filed the *Debtors’ Emergency Motion for Interim and Final Orders (A) Authorizing the Debtors to Assume Closing Store Agreement; (B) Authorizing and Approving Closing Sales Free and Clear of All Liens, Claims and Encumbrances; (C) Authorizing the Implementation of Customary Employee Bonus Program and Payments to Non-Insiders Thereunder; (D) Approving Dispute Resolution Procedures; and (E) Approving the Debtors’ Store Closing Plan* [Docket No. 15] (the “Motion”),² pursuant to which, among other things, the Debtors sought authority to conduct Closing Sales at certain designated locations. The Debtors subsequently filed a notice [Docket No. 93] (the “Designation Notice”) designating certain locations (the “Store Closing Locations”) as Closing Stores at which the Debtors were seeking authority to conduct Closing Sales pursuant to the relief requested in the Motion.

PLEASE TAKE FURTHER NOTICE that, on March 3, 2016, the Court approved the Motion on an interim basis.

PLEASE TAKE FURTHER NOTICE that Store # 127, located at 8055 West Bowles Avenue, Suite 2, Littleton, Colorado 80123 (the “Bowles Store”), was inadvertently listed as a Store Closing Location in the Designation Notice. For the avoidance of doubt, the Bowles Store is not a Store Closing Location. The Designation Notice, and the list of Store Closing Locations attached thereto, otherwise remains accurate in all respects, and the Debtors have obtained interim authority to conduct going-out-business sales at all Store Closing Locations identified on Exhibit A hereto.
