This will enable you to monitor the hearing. You will also be provided with an opportunity to submit questions by electronic mail prior to the hearing that the Trustee will attempt to address prior to or at the hearing.   - The party's role in the case (whether they are a creditor, party in interest, a participant in TelexFree or otherwise)
  - The basis of the party's objection or reason for requesting an opportunity to be heard
  - Contact information, including the telephone number and email address that the party intends to use to access the Participant Connection
- After a party has complied with the above requirements, the instructions for the Participant Connection will be sent to them by the Chapter 11 Trustee.
