Under the Plan, the Liquidation Trustee shall file a report each quarter that sets forth (i) the receipt and disposition by the Liquidation Trustee of property of the Estate or the Debtor during the prior quarter, including the disposition of funds in the Liquidation Trust; (ii) all Disputed Claims resolved by the Liquidation Trustee during such period; (iii) the status of Rights of Action; and (iv) such other information the Liquidation Trustee reasonably determines should be included in such report. Page 2 summarized the receipt and disposition of property of the Estate or the Debtor during the prior quarter.

(ii) DISPUTED CLAIMS RESOLVED DURING THE QUARTER ENDING: June 30, 2019

As described below, the Debtor has made substantial progress toward liquidating its remaining claims and causes of action against third parties. As a result, the Liquidation Trustee is in the process of reconciling all filed priority and general unsecured claims. On November 20, 2018, the Court entered an order [D.I. 713] extending the Liquidation Trustee's deadline to object to all claims through and including May 15, 2019.

(iii) STATUS OF RIGHTS OF ACTION FOR THE QUARTER ENDING: June 30, 2019

The core Rights of Action transferred to the Liquidation Trust were as follows: (a) causes of action against Blackstreet Capital Management LLC and its affiliates (collectively, "Blackstreet"); (b) causes of action against Monroe Capital Management Advisors LLC and its affiliates (collectively, "Monroe"); (c) causes of action against the Debtor's directors and officers (collectively, the "D's & O's") for breach of fiduciary duty; and (d) preference actions against counterparties that received potential preference payments.

On or about August 28, 2017, the Liquidation Trustee settled the estate's claims against the D's&O's in exchange for a cash payment from one of the Debtor's insurance carriers.

On or about May 11, 2018, the Liquidation Trustee settled the estate's claims against Monroe.

On or about May 30, 2018, the Liquidation Trustee settled the estate's claims against Blackstreet.

The Liquidation Trustee had also begun the process of settling preference actions. The process has since been outsourced to a third party recovery services firm. Proceeds from settled preference actions currently remain in the possession of that firm.
