NOTICE OF HEARING ON MOTION SEEKING ENTRY OF AN ORDER APPROVING

PLEASE TAKE NOTICE that P-D Valmiera Glass USA Corp., the debtor and debtor-in-possession in the above-referenced Chapter 11 case (the “Debtor”), by and through the undersigned counsel, filed the *Motion Seeking Entry of an Order Approving Settlement Agreement By and Between P-D Valmiera Glass USA, Corp. and Fireman’s Fund Insurance Company* [Dkt. No. 351](the “Motion”) seeking approval of that certain Agreement (as that term is defined in the Motion) resolving claims asserted by the Debtor for damage sustained in October 2018 from Hurricane Michael. PLEASE TAKE FURTHER NOTICE that pursuant to General Order No. 24-2018, the Court may consider the Motion without further notice or a hearing if no party in interest files a response opposing the Motion on or before August 14, 2020. If you oppose the relief requested in the Motion, you must timely file your response in opposition to the Motion with the Bankruptcy Clerk at Clerk, U.S. Bankruptcy Court, 75 Ted Turner Drive, SW, Room 1340, Atlanta, Georgia 30303, and serve a copy on the Debtor’s attorney, Ashley R. Ray, Scroggins & Williamson, P.C., 4401 Northside Parkway, Suite 450, Atlanta, GA 30327 by the response deadline. The response must explain your position and be actually received by the Bankruptcy Clerk within the required time.

PLEASE TAKE FURTHER NOTICE that a hearing on the Motion has been scheduled for August 25, 2020, at 10:00 a.m., in Courtroom 1401, United States Courthouse, 75 Ted Turner Drive, SW, Atlanta, Georgia 30303. Given the current public health crisis, the Hearing may be telephonic only. Please check the “Important Information Regarding Court Operations During COVID-19 Outbreak” tab at the top of the GANB website prior to the Hearing for instructions on whether to appear in person or by phone.

If a response is timely filed and served, the hearing will proceed as scheduled. If you do not file a response within the time permitted, the Court may grant the relief requested without further notice or a hearing provided that an order approving the relief requested is entered at least one business day prior to the scheduled hearing. If no response is timely filed,



but no order is entered granting the relief requested at least one business day prior to the hearing, the hearing will be held at the time and place as scheduled.

Your rights may be affected. You should read these papers carefully and discuss with your attorney, if you have one in this bankruptcy case. If you do not have an attorney, you may wish to consult one.
