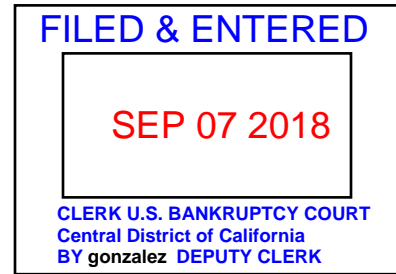



1 Having reviewed the *Debtors' Emergency Motion For Entry Of An Order Authorizing The*
2 *Filing Under Seal Of Confidential Patient Information; Memorandum Of Points And Authorities;*
3 (the "Motion") [Docket No. 21], the Declaration Of Richard G. Adcock [Docket No. 8] filed in
4 connection with and in support of First Day Motions; Declaration Of John A. Moe, II
5 [Docket No. 21], in support of the Motion; the Court having jurisdiction to consider the Motion
6 and relief requested therein, in accordance with 28 U.S.C. §§ 157 and 1334; consideration of the
7 Motion and relief requested therein being a core proceeding pursuant to 28 U.S.C. § 157(b); venue
8 being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; due and proper notice of
9 the Motion having been provided; it appearing that no further notice need be provided; the Court
10 having determined that the relief sought in the Motion is in the best interests of the Debtors,
11 creditors and all parties-in-interest; the Court having determined that the legal and factual basis set
12 forth in the Motion establish just cause for the relief granted herein; **and for the reasons set forth in**
13 **the Court's tentative ruling [Doc. No. 114], which the Court adopts as its final ruling and which is**
14 **incorporated herein by reference;** and upon all of the proceedings had before the Court and after
15 due deliberations sufficient cause appearing therefor,

16 IT IS HEREBY ORDERED that:

- 17 1. The Motion is granted;
- 18 2. The Debtors are authorized to file confidential patient information under seal; and
- 19 3. The Order shall be immediately effective and enforceable upon its entry; and;
- 20 4. The Court shall retain jurisdiction to hear and determine all matters arising from or
21 related to the implementation or interpretation of this Order.
