1 **STIPULATION**

2 This stipulation is entered into between Verity Health System Of California, Inc. and the
3 above-referenced affiliated debtors and debtors in possession in the above captioned chapter 11
4 bankruptcy cases (collectively, the “Debtors”), on the one hand, and AppleCare Medical Group,
5 Inc., AppleCare Medical Group St. Francis, Inc., and AppleCare Medical Management, LLC
6 (collectively, “AppleCare”), on the other hand.

7 **RECITALS**

8 A. On July 2, 2020, the Debtors filed the *Second Amended Joint Chapter 11 Plan of*
9 *Liquidation (Dated July 2, 2020) of the Debtors, the Prepetition Secured Creditors, and the*
10 *Committee* [Docket No. 4993] (the “Plan”) and related *Disclosure Statement Describing Second*
11 *Amended Joint Chapter 11 Plan of Liquidation (Dated July 2, 2020) of the Debtors, the*
12 *Prepetition Secured Creditors, and the Committee* [Docket No.4994].

13 B. On July 2, 2020, the Court entered the *Order Granting Joint Motion for an Order*
14 *Approving: (I) Proposed Disclosure Statement; (II) Solicitation and Voting Procedures; (III)*
15 *Notice and Objection Procedures for Confirmation of Amended Joint Plan; (IV) Setting*
16 *Administrative Claims Bar Date; and (V) Granting Related Relief* [Docket No. 4997] (the
17 “Order”), setting the hearing on confirmation of the Plan (the “Confirmation Hearing”) on August
18 12, 2020, at 10:00 a.m. (Pacific Time). *See* Order at 14. The Court also set July 30, 2020, as the
19 deadline to file objections to confirmation of the Plan (the “Objection Deadline”) and August 5,
20 2020, as the deadline to file replies (the “Reply Deadline”) in support of the Plan. *See id.* at 15-
21 16.

22 C. On July 31, 2020, the Court entered an order [Docket No. 5301] approving a
23 stipulation [Docket No. 5284] between the parties to continue the AppleCare Objection Deadline
24 to August 3, 2020, and continue the Reply Deadline for any objection filed by AppleCare to
25 August 7, 2020.

26 D. On August 3, 2020, AppleCare filed *AppleCare Medical Group, Inc., AppleCare*
27 *Medical Group St. Francis, Inc., and AppleCare Medical Management, LLC’s Objection to*
28 *Confirmation of Joint Chapter 11 Plan of Liquidation of Verity Health System of California and*

1 *its Affiliated Debtors* [Docket No. 5339] (the “Objection”). On August 7, 2020, the Court entered
2 an order [Docket No. 5406] approving a stipulation [Docket No. 5398] between the parties to
3 continue the Reply Deadline with respect to the Objection to August 9, 2020.

4 E. The Parties continue to engage in negotiations concerning the Plan and the
5 Objection, and jointly agree to extend the Reply Deadline to allow additional time to engage in
6 negotiations.

7 **AGREEMENT**

8 NOW, THEREFORE, all of the Parties to this Stipulation hereby stipulate and agree that
9 the Reply Deadline shall be extended from August 9, 2020, to August 10, 2020, at 5:00 p.m.
10 (Pacific Time), with respect to the Objection.


