SEQUITUR PERMIAN, LLC'S STATEMENT OF POSITION AND CONSENT TO JURISDICTION OF BANKRUPTCY COURT TO ENTER A FINAL ORDER

COMES NOW, Defendant/Counter-Plaintiff/Third-Party Plaintiff, SEQUITUR PERMIAN, LLC ("Sequitur"), in the above styled and numbered cause and files this Statement of Position and Consent to Jurisdiction of Bankruptcy Court to Enter a Final Order, and respectfully states as follows:

I. Statement of Position and Consent to Jurisdiction

1. Sequitur contends that MAALT, LP's claims against Sequitur for breach of contract and declaratory judgment are non-core matters. Sequitur also contends that its counterclaims against MAALT, LP ("MAALT") and third-party claims against Vista Proppants and Logistics, LLC ("Vista LLC") for promissory estoppel, negligent misrepresentation, fraudulent inducement, breach of contract, declaratory judgment and vicarious liability are non-core matters.

2. Notwithstanding the foregoing, Sequitur consents to the entry of a final judgment by this Court on all claims asserted by or between Sequitur, MAALT and Vista LLC.

3. No jury demand has been filed by MAALT or Sequitur as to any pending claims. In addition, the Terminal Services Agreement between MAALT and Sequitur contains a waiver of jury trial.

4. If a jury demand is made by any party as to any pending claims, and the Court determines that the jury waiver does not apply, then Sequitur consents to a jury trial of such claims before this Court.
